## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”), dated as of July 31, 2012, is made in favor of Forbes LLC (the “Grantor”) by JPMORGAN CHASE BANK, N.A., in its capacity as administrative agent (in such capacity, the “Administrative Agent”) pursuant to the First Amended and Restated Credit Agreement, dated as of July 6, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”) among Forbes Media LLC, as borrower (the “Borrower”), the guarantors party thereto (the “Guarantors”), the lenders party thereto and the Administrative Agent.

**WHEREAS**, pursuant to the terms and conditions of that certain (i) Amended and Restated Security Agreement (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”) dated as of July 6, 2007 among the Borrower, the Guarantors and the Administrative Agent; (ii) Short-Form United States Trademark Security Agreement (the “Short-Form Security Agreement”) dated August 4, 2006 between the Grantor and the Administrative Agent; and (iii) Amended and Restated Short-Form United States Trademark Security Agreement (the “Trademark Security Agreement”) dated July 6, 2007, between the Grantor and Investopedia LLC, the Grantor granted to the Administrative Agent a continuing security interest in all of its right, title and interest in and to the Trademarks including, without limitation, the Trademark registrations and applications set forth on Schedule I hereto together with the goodwill associated therewith (collectively, the “Trademark Collateral”); and

**WHEREAS** the Short-Form Security Agreement relating to the Trademark Collateral has been recorded with the Assignments Division of the U.S. Patent and Trademark Office on August 11, 2006 at Reel 3367 and Frame 0889.

**WHEREAS** the Trademark Security Agreement relating to the Trademark Collateral has been recorded with the Assignments Division of the U.S. Patent and Trademark Office on May 12, 2009 at Reel 3987 and Frame 0256.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the Trademark Collateral (including without limitation, for the avoidance of doubt, any Trademark Collateral, whether registered or unregistered).

If and to the extent the Administrative Agent has acquired any right, title or interest to any of the Trademark Collateral, it hereby assigns and transfers such rights, title or interest to the Grantor. The Administrative Agent shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor to further evidence and effectively effectuate the purposes of this Release.

This Release shall be construed in accordance with and governed by the laws of the State of New York.
