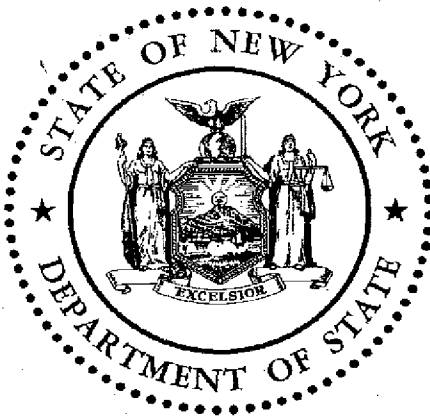

CERTIFICATE OF MERGER
OF
VERIFONE TRANSPORTATION SYSTEMS, INC.,
A NEW YORK CORPORATION
INTO
VERIFONE, INC.,
A DELAWARE CORPORATION
UNDER SECTION 907 OF THE NEW YORK BUSINESS CORPORATION LAW

Pursuant to Section 907 of the New York Business Corporation Law, the undersigned corporation executed the following Certificate of Merger:

- 1) The name of each constituent corporation is VeriFone, Inc., a Delaware corporation and VeriFone Transportation Systems, Inc., a New York corporation.
- 2) The certificate of incorporation for Taxitronic, Inc. (now VeriFone Transportation Systems, Inc.) a New York corporation, was filed by the New York Department of State on July 24, 1997.
- 3) The name of the surviving corporation in the merger is VeriFone, Inc., a Delaware corporation.
- 4) VeriFone Transportation Systems, Inc. The authorized capital stock of VeriFone Transportation Systems, Inc. consists of 1,750 shares of common stock, no par value per share ("VTS Common Stock"). As of the date of this Agreement and at the time of the merger, 1,403 shares of VTS Common Stock are and will be outstanding, all of which are and will be held by VeriFone.
- 5) VeriFone. The authorized capital stock of VeriFone, Inc. consists of 1,000 shares of common stock, par value \$0.01 per share ("VeriFone Common Stock"). As of the date of this Agreement, 1,000 shares of VeriFone Common Stock are outstanding.
- 6) The Agreement of Merger (the "Merger Agreement") is permitted by the laws of the State of Delaware and is in compliance therewith.
- 7) The Merger Agreement, dated as of November 23, 2010, has been approved and adopted by a majority vote at a meeting of shareholders of VeriFone Transportation Systems, Inc.
- 8) The merger is to become effective upon filing of this Certificate of Merger.
- 9) The surviving corporation was incorporated on June 3, 1986 and is qualified to do business in the State of New York as of September 8, 1989.

- 10) The surviving corporation agrees that it may be served with process in the state of New York in any action or special proceeding for the enforcement of any liability or obligation of any domestic corporation or of any foreign corporation, previously amenable to suit in New York, which is a constituent corporation in this merger, including any suit or other proceeding to enforce the right of any shareholders of VeriFone Transportation Systems, Inc. to receive payment for their shares against the surviving corporation. Pursuant to section 306 of the Business Corporation Law of New York, the surviving corporation designates the Secretary of State of New York as its agent upon whom process against it may be served in accordance with paragraph (b) of section 306 of the Business Corporation Law of New York for any action or proceeding. The Secretary of State shall mail any such process to the surviving corporation at the following address: VeriFone, Inc., 2099 Gateway Place, Suite 600, San Jose, CA 95110.
- 11) Subject to the provisions of section 623 of the Business Corporation Law of New York, the surviving corporation will promptly pay the shareholders of VeriFone Transportation Systems, Inc. the amount, if any, to which they are entitled under the provisions of the Business Corporation Law of New York relating to the right of shareholders to receive payment for their shares.
- 12) All fees and taxes (including penalties and interest) administered by the department of taxation and finance which are due and payable as of the time of the execution of this instrument have been paid. A cessation franchise tax report through the anticipated date of the merger has been filed by VeriFone Transportation Systems, Inc. Within thirty days of the execution of this instrument, the surviving corporation agrees to promptly pay the department of taxation and finance all fees and taxes (including penalties and interest) if any due to the department of taxation and finance by VeriFone Transportation Systems, Inc.
