TRADEMARK ASSIGNMENT

WHEREAS, Tandus Flooring Limited, a Corporation duly organized and existing under the laws of Canada and having offices at 43 Willow Street, Truro Nova Scotia, Canada B2N5G2, hereinafter referred to as "ASSIGNOR," has adopted and used and is the owner of the trademarks set forth on Schedule A hereto in connection with the goods described therein (the "Marks"), together with the goodwill of the business in connection with which the Marks have been used (the "Goodwill") and the Trademark Registrations for the Marks set forth on Schedule A (the "Registrations"); and

WHEREAS, Tandus Flooring US, LLC, a Limited Liability Company duly organized and existing under the laws of Delaware and having its principal office at 311 Smith Industrial Boulevard, Dalton, Georgia 30721-8661, hereinafter referred to as "ASSIGNEE," is desirous of acquiring the Marks, together with the Goodwill and the Registrations;

NOW, THEREFORE, for One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR has agreed to sell and has sold, assigned, transferred and set over, and by these presents does sell, assign, transfer and set over unto ASSIGNEE and its successors and assigns ASSIGNOR's entire right, title, and interest in the Marks, the Goodwill, and the Registrations, including the right to sue for past infringements, to be held and enjoyed by ASSIGNEE for its own use and benefit and for the use and benefit of its subsidiaries, successors, assigns and legal representatives, for the full extent of the life of the Marks

and the term of the Registrations used as fully and entirely as such rights would have been held and enjoyed by ASSIGNOR had this Assignment and sale not been made.


ASSIGNOR covenants that ASSIGNOR is the owner of the Marks and the holder of record title to the Registrations, that ASSIGNOR has full power to make this Assignment and that ASSIGNOR agrees to execute such further assignments and related documents with respect to the Marks, the Goodwill and the Registrations as ASSIGNEE shall reasonably request.

IN WITNESS WHEREOF, each of the parties hereto has executed this Assignment, or has caused this Assignment to be executed on its behalf by a representative duly authorized, the 6th day of August, 2012.
