On the other hand,

Hereunder individually referred to as « Party » and collectively as « Parties »

1. Preamble

WHEREAS Assignor and Assignee are parent companies;

WHEREAS by virtue of an agreement entitled "Contrat de Transfert de Patrimoine et d'Apport en Nature" executed on February 27, 2012 but retroactively effective as of January 1st, 2012, Assignor transferred to Assignee, inter alia, all its trademark rights in the trademarks set forth in Schedule A (hereinafter the "Trademarks");

WHEREAS the Parties wish hereby to confirm the transfer of the Trademarks for the purpose of their recordal at the national Trademark office.

2. Agreement

Assignor confirms the transfer to Assignee of the Trademarks with all rights and privileges attached thereto, including the right to prosecute unprescribed acts of infringement.

The price for the transfer was duly paid, as expressly confirmed by the Parties.

The present agreement confirms and neither replaces nor amends the "Contrat de Transfert de Patrimoine et d'Apport en Nature".

Full powers are given to the bearer of an original hereof to proceed with its recordal at the **USPTO**.
