ATTORNEY'S LIEN CLAIM

To All Those Whom It May Concern:

This is to put you on notice of the **statutory Washington State Attorney's Lien pursuant to RCW 60.40.010(1)**, held by **Innovation Law Group, Ltd.**, 237 N. Sequim Ave, Sequim, WA 98382 (herein "ILG") in and to certain files and matters of

said David Lee Schmidkofer and Megan Alyssa Schmidkofer residing at 253 Marshall Road, Sequim WA, 98382, said lien relating to and securing unpaid attorneys fees and costs in the amount of \$2464.13 (plus time and costs accrued since May 1, 2012) due ILG by them for the prosecution of these matters, pursuant to engagement of ILG by them in 2006:
