TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is dated as of November 30, 2011 (the "Closing Date"), by and among:

(A) SKILLSOFT IRELAND LIMITED, a private limited company legally organized under the laws of Ireland (the "Assignor"); and

(B) THE TRAINING CONSORTIUM, LLC a limited liability company legally organized under the laws of Washington (the "Assignee").

RECITALS

WHEREAS, the Assignor has adopted and used and are using in commerce the Knowledgenet trademark (the "Trademark"); and

WHEREAS, the Assignee wishes to acquire from the Assignor, and the Assignor wishes to transfer to the Assignee, said Trademark and the goodwill associated with such Trademark on a conditional basis as set forth in this Agreement; and

NOW, THEREFORE, for good and valuable consideration, the adequacy and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

Section 1. Effective as of the Closing Date, the Assignor hereby assigns to the Assignee all rights, title and interests in and to the Trademark, the goodwill of the business symbolized by the Trademark, all registrations and applications for registration thereof, if any, and all rights of action accrued and to accrue under and by virtue thereof, including the right to sue and recover for past infringement of said Trademark.

Section 2. Effective upon the Closing Date, the Assignor authorizes and requests the United States Patent and Trademark Office, and any other official throughout the world whose duty is to register and record ownership in trademark registrations and applications for registration, to record the Assignee as the assignee and owner of any and all of the Assignor's rights in the Trademark being assigned to the Assignee in accordance with Schedule A.

Section 3. After the Closing Date and at the Assignee's request, the Assignor will, at the Assignee's sole expense, provide further cooperation reasonably necessary (such as executing and delivering additional assignments, affidavits, and other documents and providing information and materials) to obtain, perfect, and defend the Trademark in the United States or any foreign country.

Section 4. ASSIGNOR MAKE NO REPRESENTATIONS OR WARRANTIES OF ANY KIND AS TO THE MARKS AND DISCLAIM ALL EXPRESS OR IMPLIED WARRANTIES OF ANY KIND.

Section 5. The rights and obligations of the parties shall be governed by, and this Assignment shall be interpreted, construed and enforced in accordance with, the laws of the State of New Hampshire, excluding its conflict of laws rules to the extent such rules would apply the law of another jurisdiction.

Section 6. An electronic mail or facsimile copy of this Agreement shall be treated as an original. This Agreement may be executed simultaneously in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. This Agreement shall be binding upon the parties and their respective successors and assigns.

Section 7. Use Covenant and Restriction.

Section 8. Automatic Reversion of Ownership.

Section 9. Right of First Refusal.

Section 10. Notice.

Assignee and Assignor shall each have the right from time to time to change the place notice is to be given under this paragraph by written notice thereof to the other party.

Section 11. Miscellaneous.

Assignee may not assign this Agreement, in whole or in part, or any of its rights hereunder, whether by operation of law or otherwise, without Assignor's prior written consent. Any attempt by Assignee to assign this Agreement or its rights hereunder in breach of this section shall be void and of no effect.

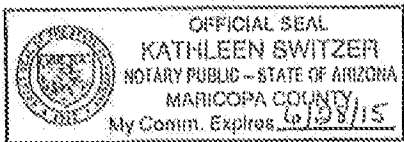
