ASSIGNMENT OF SERVICE MARK

THIS ASSIGNMENT OF SERVICE MARK is made by Cigna Intellectual Property, Inc., a Delaware corporation ("Assignor"), to MDM Golf of Gillette Ridge, LLC, a Connecticut limited liability company ("Assignee").

WHEREAS, Gillette Ridge Golf LLC, a Delaware limited liability company ("Seller"), Assignee, and MDM Golf of GR, LLC, a Connecticut limited liability company (Assignee and MDM Golf of GR, LLC being hereafter referred to collectively as "Purchaser") entered into that certain Agreement of Purchase and Sale dated February 15, 2008 ("Purchase and Sale Agreement") wherein Seller agreed to sell and Purchaser agreed to purchase certain real property located in Bloomfield Connecticut (together with the improvements thereon and the tangible and intangible personal property associated therewith) operated as the "Gillette Ridge Golf Course"; and

WHEREAS, Assignor is an affiliate of Seller and the owner of the one of the items of certain of the aforesaid intangible personal property, namely the service mark "Gillette Ridge" ("Service Mark"); and

WHEREAS, Seller and Purchaser inadvertently failed to cause Assignor to assign the Service Mark to Purchaser as required by the Purchase and Sale Agreement; and

WHEREAS, Seller and Purchaser wish to correct the failure.

NOW THEREFORE, for and in consideration of the premises and other good and valuable consideration, receipt and sufficiency of which are hereby expressly acknowledged:

1. Assignor, on behalf of Seller, does hereby assign and transfer all of its right, title and interest in and to the Service Mark to Purchaser, its successors and assigns.

2. Seller for itself and for its successors and assigns, does hereby covenant with Purchaser, its successors and assigns, (a) that Assignor it is the true and lawful owner of the Service Mark, and has full to power assign and transfer the same to the extent of its similar covenant made on the date of the Bill of Sale and Assignment, and (b) that neither Seller nor Assignor has made a prior assignment or transfer of its interest in the Service Mark. Seller makes no representation or warranty regarding (x) the status of any registration of the Service Mark or (y) any infringement of the Service Mark that may have occurred after the date of the Bill of Sale and Assignment.
