## RELEASE OF TRADEMARK SECURITY INTEREST

This Release of Trademark Security Interest (this “**Release**”) is dated as of August 10, 2012, and entered into by **Wells Fargo Bank, National Association** (“**Secured Party**”), in favor of **Skyrocket Toys LLC**, a California limited liability company (the “**Debtor**”). Capitalized terms used but not otherwise defined herein shall have the meanings ascribed to them in the Security Agreement (as defined below).

WHEREAS, reference is hereby made to that certain Assignment, Grant of Security Agreement In and Mortgage of United States Trademarks dated July 8, 2011 (the “**Security Agreement**”) between Debtor and Secured Party whereby Debtor granted to Secured Party a security interest over the MEON (Serial No. 85122362) and SKYROCKET (Serial No. 77944180) trademarks, and any form or formative thereof, and all design marks used in conjunction therewith and all of the goodwill associated therewith (collectively, the “**Trademarks**”);

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on August 1, 2011 at Reel/Frame 4595/0040;

WHEREAS, the loan/factoring facility between Debtor and Secured Party has terminated;

WHEREAS, the Secured Party now desires to terminate the Security Agreement and release its security interest in and lien on the Trademarks.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby terminates, releases, and discharges fully its security interest in and lien on the Trademarks as granted pursuant to the Security Agreement, and Secured Party reconveys, transfers, and assigns to the Debtor, without recourse, representation or warranty of any kind, any rights it may have in the Trademarks pursuant to or in connection with the Security Agreement, and any right, title or interest of Secured Party in the Trademarks shall hereby cease and become void.

Secured Party further agrees to execute and deliver to the Debtor, at the sole cost and expense of the Debtor, any and all further documents, instruments and releases, and do any and all further acts which the Debtor (or its agents or designees) reasonably request in order to confirm this Release.
