INTELLECTUAL PROPERTY RELEASE AND REASSIGNMENT

THIS INTELLECTUAL PROPERTY RELEASE AND REASSIGNMENT is made as of April 2, 2012, by GENERAL ELECTRIC CAPITAL CORPORATION, as Collateral Agent for the Lenders ("GECC").

WITNESSETH:

WHEREAS, JPMORGAN CHASE BANK, N.A. ("**JPMorgan**"), SHPS HOLDINGS, INC., a Delaware corporation, SHPS, INC., a Delaware corporation, SHPS HUMAN RESOURCE SOLUTIONS, INC., a Kentucky corporation, CAREWISE HEALTH, INC., a Delaware corporation, fka SHPS HEALTH MANAGEMENT SOLUTIONS, INC., LANDACORP, INC. (successor by merger to Promedex, Inc.), a Delaware corporation (collectively, the "**Grantors**"), were parties to that certain Guarantee and Collateral Agreement dated as of October 27, 2004 (as amended, restated, reaffirmed, supplemented or otherwise modified from time to time, the "**Guarantee and Collateral Agreement**"), pursuant to which Grantors granted a security interest to JPMorgan in certain Patent, Trademark and Copyright Collateral (as defined below) as security for certain obligations owing by Grantors to JPMorgan, including the Trademarks (as defined below) set forth on Schedule A, the Patents (as defined below) set forth on Schedule B and the Copyrights (as defined below) set forth on Schedule C hereto;

WHEREAS JPMorgan, GECC and Grantors entered into that certain Notice of Change of Collateral Agent- Patent and Trademark Security Agreement, dated as of May 28, 2009 (as amended, restated, supplemented or otherwise modified from time to time, the "**Assignment Agreement**") pursuant to which JPMorgan resigned as Collateral Agent and assigned all of its rights, powers, privileges and duties as Collateral Agent to GECC;

WHEREAS JPMorgan, GECC and Grantors entered into that certain Notice of Change of Collateral Agent- Copyright Security Agreement, dated as of May 28, 2009 (as amended, restated, supplemented or otherwise modified from time to time, the "**Copyright Assignment Agreement**") pursuant to which JPMorgan resigned as Collateral Agent and assigned all of its rights, powers, privileges and duties as Collateral Agent to GECC;

WHEREAS, the Guarantee and Collateral Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on (i) November 26, 2004, at Reel 3085 and Frame 0242, (ii) November 26, 2004, at Reel 3084 and Frame 0825, (iii) November 26, 2004, at Reel 3085 and Frame 00001, (iv) November 26, 2004, at Reel 3085 and Frame 0440, (v) November 26, 2004, at Reel 3085 and Frame 0341, (vi) November 26, 2004, at Reel 3085 and Frame 0140 and (vii) November 1, 2005, at Reel 3185 and Frame 331;

WHEREAS, the Assignment Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on June 1, 2009, at Reel 3997, Frame 0185;

WHEREAS, the Guarantee and Collateral Agreement was recorded in the Patent Division of the United States Patent and Trademark Office, on November 26, 2004, at Reel 016016 and Frame 0200;

WHEREAS, the Assignment Agreement was recorded by the Patent Division of the United States Patent and Trademark Office on June 1, 2009, at Reel 22757, Frame 0906;

WHEREAS, the Guarantee and Collateral Agreement was recorded in the United States Copyright Office on November 26, 2004, in Volume 3519, Page 926;

WHEREAS, the Copyright Assignment Agreement was recorded in the United States Copyright Office on June 10, 2009, at Volume 3577, Document 566;

WHEREAS, Grantor has requested that GECC release its security interest in the Patents, Trademark and Copyright Collateral and reassign the same to Grantors.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. GECC hereby releases its security interest in all of Grantors' right, title and interest in and to the following (collectively the "**Patent, Trademark and Copyright Collateral**"):

(a) all letters patent of the United States or any other country, all registrations and recording thereof, and all applications for letters patent of the United States or any other country, including registrations, recordings and pending applications in the United States Patent and Trademark Office or any similar offices in any other country, including those listed on Schedule B attached hereto (the "Patents");

(b) all reissues, continuations, divisions, continuations-in-part, renewals or extensions of the Patents, and the inventions disclosed or claimed in the Patents, including the right to make, use and/or sell the inventions disclosed or claimed in the Patents;

(c) all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and

registration applications in the United States Patent and Trademark Office or any similar offices in any State of the United States or any other country or any political subdivision thereof, and all extensions or renewals thereof, including those listed on Schedule A attached hereto (the "Trademarks");

(d) all goodwill associated with or symbolized by the Trademarks;
and

(e) all other assets, rights and interests that uniquely reflect or embody such goodwill.


(f) all copyright rights in any work subject to the copyright laws of the United States or any other country, whether as author, assignee, transferee or otherwise, and all registrations and applications for registration of any such copyright in the United States or any other country, including registrations, recordings, supplemental registrations and pending applications for registration in the United States Copyright Office, including those listed on Schedule C attached hereto (the "Copyrights").

2. GECC hereby reassigns, grants and conveys to Grantors, without any representation, recourse or undertaking by GECC, all of GECC's right, title and interest in and to the Patent, Trademark and Copyright Collateral.
