Trademark Assignment

This trademark assignment ("Assignment") is entered into as of July 2, 2012 ("Effective Date") by and between Carbon Audio, Inc., an Oregon corporation ("Assignor"), and Carbon Audio, LLC, a Delaware limited liability company ("Assignee").

For the membership interest in Carbon Audio, LLC, a Delaware limited liability company and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby:

(A) irrevocably assigns to Assignee:

(1) the entire right, title, and interest, everywhere in the world, to

(a) the trademarks, trademark applications and trademark registrations (including foreign counterparts therefor made under any existing or future international, bi-lateral or multi-lateral trademark conventions, agreements or treaties) set forth in Exhibit 1 attached hereto, and

(b) all of the goodwill of the business symbolized by, or otherwise associated with, the trademarks and registrations set forth in subsection (A)(1)(a) above

(all of the foregoing in this subsection (A)(1), collectively, the "Assigned Marks");

(2) the right to sue third parties for infringement (including but not limited to past, present and future infringement, damages and injunctive relief) of any of the Assigned Marks based on activities occurring prior to the Effective Date hereof or hereafter; and

(3) any current or future right to receive royalties based on any of the foregoing; and

(B) agrees upon the request (and at the expense) of Assignee (or its successors, assigns or legal representatives) to, and if Assignor is unable or unwilling to do so authorizes Assignee to act in Assignor's name to: (i) execute all oaths, assignments, powers and other documents, (ii) testify in any proceedings and otherwise take any action, and (iii) otherwise fully cooperate with Assignee, in each case to the extent reasonably necessary to perform Assignor's obligations hereunder in connection with securing, perfecting, enforcing and defending the Assigned Marks and Assignee's rights related to this Assignment, and in furtherance of the foregoing Assignor hereby appoints Assignee as Assignor's agent and attorney in fact for, and grants to Assignee a power-of-attorney with full power of substitution, to execute, deliver and file any documents, and perform any acts, Assignee would otherwise lawfully be obligated to execute, deliver, file or perform pursuant to this sub-section (B), with the same legal force and effect as if executed, delivered, filed or performed by Assignor, and such power of attorney shall be deemed coupled with an interest for the purposes of effecting the foregoing assignments.

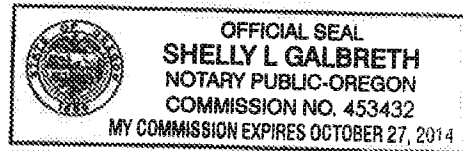

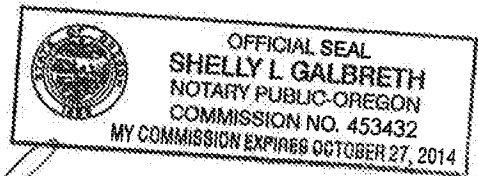
