RELEASE OF SECOND LIEN TRADEMARK COLLATERAL

(Grand Falls Casino Resort, LLC – Second Lien Facility)

THIS RELEASE OF SECOND LIEN TRADEMARK COLLATERAL (this “Release”) is made as of August 14, 2012, by WELLS FARGO BANK, NATIONAL ASSOCIATION, as administrative agent (in such capacity as the “Second Lien Administrative Agent”), the secured party under the Second Lien Security Agreement referred to below.

WITNESSETH:

WHEREAS, GRAND FALLS CASINO RESORT, LLC (“Grantor”), and certain other entities executed that certain Second Lien Security Agreement, dated as of December 17, 2010 (the “Second Lien Security Agreement”), pursuant to which Grantor granted a security interest to the Second Lien Administrative Agent in certain trademarks and other intellectual property of Grantor; and

WHEREAS, a Second Lien Grant of Security Interest – Trademarks executed in connection with said Second Lien Security Agreement was recorded with the United States Patent and Trademark Office at Reel 004436, Frame 0147 on December 17, 2010; and

WHEREAS, the Second Lien Administrative Agent has agreed to release all its liens on the trademarks and trademark applications of Grantor identified on Exhibit A attached hereto and made a part hereof (the “Released Collateral”), and to reconvey any and all rights in the Released Collateral to the persons legally entitled thereto.

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, the Second Lien Administrative Agent hereby releases all its rights in and to the Released Collateral, reconveys to the persons legally entitled thereto all of the Second Lien Administrative Agent’s right, title and interest in and to the Released Collateral, all without warranty or representation of any kind.
