INTELLECTUAL PROPERTY SECURITY RELEASE

This INTELLECTUAL PROPERTY SECURITY RELEASE (the "*IP Security Release*") is made as of August 16, 2012 by NB HOLDINGS CORPORATION (successor in interest to Security Pacific Business Credit Inc. ("*SPBC*")) (the "*Releasing Party*") in favor of STRATEGIC PARTNERS, INC. (the "*Grantor*").

WHEREAS, a security interest in favor of SPBC was recorded by SPBC with the United States Patent and Trademark Office on May 30, 1989, at Reel 00905, Frame 0951, on April 22, 1993, at Reel 00959, Frame 0145, and on July 22, 1993 at Reel 00983, Frame 0296, with respect to certain U.S. trademarks and trademark applications identified in Schedule A hereto (the "*Released Collateral*"); and

WHEREAS, the Releasing Party, successor in interest to SPBC, now desires to release its security interest in and to the Released Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Releasing Party agrees as follows:

SECTION 1. Release of Security Interest. The Releasing Party does hereby release, without recourse, representation or warranty of any kind, all of the Releasing Party's right, title and interest in and to the Released Collateral.

SECTION 2. Recordation. The Releasing Party authorizes and requests that the United States Commissioner for Trademarks and any other applicable officer in any successor office or any similar office in any other country record this IP Security Release.


SECTION 3. Governing Law. This IP Security Release shall be governed by, and construed in accordance with, the laws of the State of New York.
