Assignor does hereby irrevocably assign, sell, transfer, and set over to Assignee, its successors and assigns, its entire right, title, and interest in, to, and under the Mark, together with all of the goodwill associated therewith and symbolized thereby, including:

all statutory and common law rights attaching thereto, including all rights associated with the Mark by virtue of their use in commerce; and

the exclusive right to bring, make, oppose, or defend any proceedings, claims, or other causes of action pertaining to the validity, enforceability, or infringement of the Marks and to obtain relief (and to retain any damages recovered) for infringement of the Mark, regardless of whether the infringement occurred before, on, or after the Effective Date of this Agreement.
