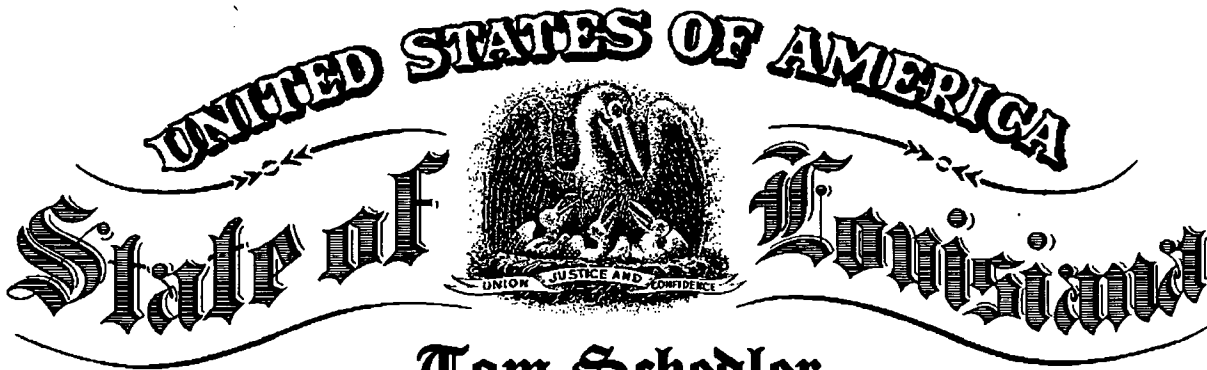

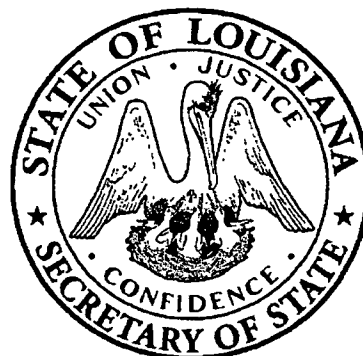

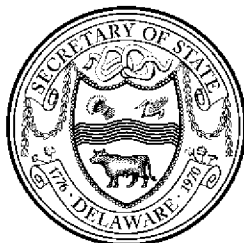

4. The Certificate of Incorporation of Surviving Corporation shall remain its Certificate of Incorporation.


