## RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST (this “Release”) made as of August 14, 2012, is granted by BNP PARIBAS, as Administrative Agent (“BNP”) in favor of FOSTER WHEELER LLC, FOSTER WHEELER INC., FOSTER WHEELER USA CORPORATION, FOSTER WHEELER NORTH AMERICA CORP., FOSTER WHEELER ENERGY CORPORATION, FOSTER WHEELER INTERNATIONAL CORPORATION, FOSTER WHEELER AG, FOSTER WHEELER LTD, FOSTER WHEELER HOLDINGS LTD., FOSTER WHEELER DEVELOPMENT CORPORATION and FOSTER WHEELER BIODYNAMICS, INC. (each an “Obligor” and, collectively, the “Obligors”).

WHEREAS, under the terms of that certain Amended and Restated Security Agreement, between the Obligors and BNP, dated as of July 30, 2010 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), the Obligors entered into that certain Intellectual Property Security Agreement, dated as of July 30, 2010 (the “Intellectual Property Security Agreement”), for recordation with the United States Patent and Trademark Office;

WHEREAS, the Intellectual Property Security Agreement was recorded in the United States Patent and Trademark Office on August 27, 2010 at Reel 004268, Frame 0802;

WHEREAS, pursuant to the terms and conditions of the Security Agreement and the Intellectual Property Security Agreement, each Obligor pledged and granted to BNP for the benefit of the Secured Parties, a security interest in all of such Obligor’s right, title and interest in, to and under the Trademark Collateral (as defined below);

WHEREAS, pursuant to Section 5.12 of the Security Agreement, the Obligors requested, and in consideration of its obligations under Section 5.12 of the Security Agreement, BNP has agreed, that BNP release its lien on and security interest in each of the Obligor’s right, title and interest in, to and under the Trademark Collateral (as defined below).

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, BNP hereby agrees as follows:

### SECTION 1. Definitions.

(a) The term “Trademark,” as used herein, shall mean all trade names, trademarks and service marks, logos, trademark and service mark registrations, and applications for trademark and service mark registrations, including all renewals of trademark and service mark registrations, all rights to recover for all past, present and future infringements thereof and all rights to sue therefor, and all rights corresponding thereto throughout the world.

(b) The term “Trademark Collateral,” as used herein, shall mean all Trademarks, whether now owned or hereafter acquired by any Obligor, including each Trademark identified in Schedule I hereto, together, in each case, with the product lines and goodwill of the business connected with the use of, and symbolized by, each such trade name, trademark and service mark. Notwithstanding the foregoing, the Trademark Collateral does not and shall not include

any Trademark that would be rendered invalid, abandoned, void or unenforceable by reason of its being included as part of the Trademark Collateral.

(c) Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meanings given to them in the Security Agreement.

SECTION 2. Release of Security Interest. BNP hereby releases, relinquishes and discharges, without representation, recourse or warranty whatsoever, all of its lien on and security interest in and to the Trademark Collateral, and any right, title or interest of BNP in, to or under the Trademark Collateral shall hereby cease and become void.



SECTION 4. Governing Law. This Release shall be construed in accordance with and governed by the law of the State of New York.
