ASSIGNMENT OF TRADEMARK

Agreement made this 26th day of April, 2012 between INTERNATIONAL PROVISIONS, INC. a Corporation organized and existing under the laws of the State of Connecticut with offices at 13 Hamden Park Drive, Hamden, Connecticut, and hereinafter referred to as "Assignor," and HOWARD'S SNACKS, LLC, a Connecticut Limited Liability Company with offices at 6 Hamden Park Drive, Hamden, Connecticut, and hereinafter referred to as "Assignee."

WITNESSETH:

WHEREAS, INTERNATIONAL PROVISIONS, INC., with offices at 13 Hamden Park Drive, Hamden, Connecticut, is the owner of all right, title, and interest and has used in its business the trademark "HOWARD'S & Design", which mark is registered with the United States Patent and Trademark Office, Registration No. 3950626, dated April 26, 2011, and as more fully described in Exhibit "A" attached hereto (the "Trademark"); and

WHEREAS, HOWARD'S SNACKS, LLC, with offices at 6 Hamden Park Drive, Hamden, Connecticut, is desirous of acquiring the entire right, title, and interest in and to the said Trademark, the registration thereof, and in and to any registrations, renewals, and extensions that may be granted thereon, together with the goodwill of the business connected therewith; and

WHEREAS, pursuant to a certain Purchase and Sales Agreement entered into on December 23, 2011 between Assignor and Assignee, Assignee has agreed to purchase and Assignor has agreed to sell certain assets of Assignor including the aforementioned trademark, which agreement is incorporated in full herein by reference; and

NOW, THEREFORE, the parties, for good and valuable consideration, the receipt whereof is hereby acknowledged, mutually agree as follows;

1. Assignment of Trademark

Pursuant to the Purchase and Sale Agreement entered into on December 23, 2011 between Assignor and Assignee, Assignor has sold, assigned, transferred, and by these presents does hereby sell, assign, and transfer unto the said Assignee all right, title, and interest in said Trademark registrations and in and

to any registrations, renewals, and extensions that may be granted thereon, together with the goodwill of the business connected herewith and any right to recover for past infringement.


2. Warranties

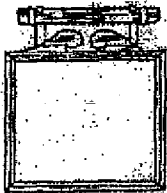
