For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor does hereby assign unto the Assignee all of Assignor's right, title, and interest in the United States of America, and worldwide in and to: (i) the Assignor's: registered and unregistered domestic and foreign symbols, logos, intellectual property, domain names, trademarks, servicemarks, trade dress, trademark applications and registrations, trade names and variations thereof, together with all of the goodwill associated with and symbolized by such marks, used primarily in connection with the operation of that certain ski resort facility located in Oxford County, Maine and commonly known as the "Sunday River Ski Resort", including, without limitation, all trademarks, trademark applications, domain names and trade names, on **Schedule A** attached hereto (collectively, the "**Marks**"); (ii) Assignor's patents, inventions disclosures or inventions, including all processes, machines, manufactures and compositions of matter, designs and any other inventions that may be the subject matter of patent protection, and all worldwide statutory or other legal protection obtained or obtainable therein, including without limitation all published and granted patents and pending applications and provisionals, reissues, divisionals, renewals, extensions, continuations, and continuations-in-part, design patents and industrial design registrations, including the patent listed on **Schedule A** attached hereto (collectively, the "**Patents**"); and (iii) all of Assignor's copyrightable materials and works, whether or not such works are registered, and all worldwide copyright rights and ownership in and to the works, including the right to seek and hold registrations of the claim of copyright in any jurisdiction providing for same and all of Assignor's right, title and interest in the objects that embody the works, including all previous versions of the works whether registered or not, which are used primarily in connection with the operation of that certain ski resort facility located in Oxford County, Maine and commonly known as the "Sunday River Ski Resort", and whether or not listed on **Schedule A** attached hereto (collectively, the "**Copyrighted Works**" and together with the Marks and the Patents, the "**Intellectual Property**"); free and clear of all liens and encumbrances, and any rights of the Assignor to any claims for infringement of such Intellectual Property, and the right to sue any third parties for any past infringement of or to the Intellectual Property, as well as all rights to damages or profits, due or accrued, arising out of such past infringement, for the use of Assignee and its successors, assigns or other legal representatives and to prosecute all applications and registrations of the Intellectual Property in the United State of America and worldwide.

After the execution of this Assignment, at the request of the Assignee and without additional consideration to the Assignor, the Assignor will execute and deliver to the Assignee from time to time such further instruments of conveyance, transfer, and assignment and other documents, and will take such other actions, as the Assignee may reasonably require to convey and deliver more effectively to the Assignee the Marks, to perfect the Assignee's title thereto, and otherwise to accomplish the orderly transfer to the Assignee of the Marks and to give full effect to this Assignment.






