RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST dated as of August 10, 2012 (the "Release") is made by Citibank, N.A., ("Citibank") in its capacity as Secured Party pursuant to that General Security Agreement dated November 1, 1999 by and between Citibank and Blue Man Productions, Inc. (now, by merger, Blue Man Productions, LLC) ("BMP").

WHEREAS, to secure BMP's obligations as creditor to Citibank in a Revolving Credit Agreement dated November 1, 1999, BMP granted a security interest in all its right, title and interest in and to the U.S. trademarks and trademark applications or registrations set forth on Scheduled A hereto, together with the goodwill of the business symbolized by such trademarks and all claims for damages for past infringement of such trademarks (the "Trademarks");


WHEREAS, the aforesaid security interest was recorded with the U.S. Patent and Trademark Office at Reel 2069, Frame 0642;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Citibank does hereby release all of its security interest, liens and encumbrances in, to and under the Trademarks, and discharge and relinquish unto BMP, any and all right, title and interest it has in, to and under the Trademarks under the General Security Agreement.


