**REASSIGNMENT AND RELEASE OF SECURITY INTEREST –  
PATENTS AND TRADEMARKS**

This Reassignment and Release of Security Interest (this “Release”) is made as of June 22, 2012 by PNC Bank, National Association (“**PNC**”), successor by merger to National City Bank, in its capacity as agent (PNC in such capacity, “**Agent**”), in favor of EASTMAN OUTDOORS, INC., a Michigan corporation and GORILLA, INC., a Michigan corporation (collectively, the “Company”).

Recitals

WHEREAS, the Company received certain financial accommodations from the Agent, and in connection therewith entered into a Patent and Trademark Security Agreement with Agent dated as of October 26, 2009 (as amended or modified from time to time, the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, the Company pledged, assigned and granted to the Bank, a security interest in the patents and patent applications identified on Schedule 1 to this Release (collectively, the “Patents”);

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office at Reel/Frame 023456/0453 on November 3, 2009;

WHEREAS, pursuant to the Security Agreement, the Company pledged, assigned and granted to the Bank, a security interest in the trademarks and trademark applications identified on Schedule 2 to this Release (collectively, the “Trademarks”);

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office at Reel/Frame 004089/0906 on November 3, 2009;

WHEREAS, the Company has paid all or a substantial portion of the indebtedness owing to the Agent; and

WHEREAS, the Agent wishes to reassign to Company and release all interest that Agent may have in the Patents and Trademarks.


Agreement
