## RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY (this "Release") is made as of August 14, 2012 ("Effective Date") by Bank of America, N.A., as successor by merger to LaSalle Bank National Association ("Grantee"), in favor of Lawson Products, Inc., an Illinois corporation ("Grantor").

WHEREAS, Grantor is a party to that certain First Amended and Restated Credit Agreement dated as of November 7, 2008 (the "Original Agreement"), entered into by and between Lawson Products, Inc., a Delaware corporation, and various Subsidiaries thereof (collectively, the "Borrowers") and Bank of America, N.A., successor by merger to LaSalle Bank National Association (the "Lender"), as amended by the First Amendment to First Amended and Restated Credit Agreement dated as of March 9, 2009 (the "First Amendment"), and as further amended by the Waiver and Second Amendment to First Amended and Restated Credit Agreement dated as of July 2, 2009 (the "Second Amendment, and together with the Original Agreement and the First Amendment, hereinafter collectively referred to as the "Credit Agreement");

WHEREAS, to secure its obligations under the Credit Agreement, Grantor granted to Grantee a continuing security interest in and to all of Grantor's right, title and interest in, to and under all of Grantor's trademarks, trademark registrations, trademark applications, trade names and trade styles, brand names, service marks, service mark registrations and service mark applications, including, without limitation, the trademarks, trade names, brand names, service marks and applications and registrations thereof set forth on Schedule I attached hereto (the "Trademarks");

WHEREAS, to secure its obligations under the Credit Agreement, Grantor granted to Grantee a continuing security interest in and to all of Grantor's right, title and interest in, to and under all of Grantor's copyrights and applications and registrations thereof, including, without limitation, the copyright applications and registrations set forth on Schedule II attached hereto (the "Copyrights, and together with the Trademarks, the "Intellectual Property"); and

WHEREAS, Grantor has satisfied and discharged all of its outstanding indebtedness and other obligations to the Lender under the Credit Agreement and related documents; provided however, for purposes of clarity, Grantor remains obligated to the Lender for all Continuing Obligations (as such term is defined in that certain Payoff Letter Relating to That Certain First Amended and Restated Credit Agreement, dated as of November 7, 2008, as amended, dated August 21, 2009 by the Lender to the Borrowers).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates, cancels and releases any and all security interests that Grantor may have in or to the Intellectual Property.

Grantee represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any

security interest that Grantee may have in or to the Intellectual Property; and (iii) it has not recorded or otherwise evidenced security interest with respect to the Intellectual Property, other than those of the foregoing set forth on Schedules I and II attached hereto, in any jurisdiction throughout the world.


Grantee shall, at Grantor's expense, take all actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor to more fully and effectively effectuate the purposes of this Release.

This Release shall be governed and construed in accordance with the laws of the State of Illinois without regard to conflicts of law principles thereof and shall be binding upon Grantee's representatives, successors, assigns and transferees.




