TRADEMARK RELEASE

THIS TRADEMARK RELEASE is made as of August 23, 2012, by GE BUSINESS FINANCIAL SERVICES INC., formerly known as Merrill Lynch Capital, a division of Merrill Lynch Business Financial Services Inc., as Agent (“**Agent**”).

WITNESSETH:

WHEREAS, Agent and DYNAVOX SYSTEMS LLC, a Delaware limited liability company (“**Grantor**”), were parties to that certain Trademark Security Agreement dated as of May 13, 2004 (the “**Assignment**”), pursuant to which Grantor granted a security interest to Agent in certain trademarks (the “**Trademarks**”) and Trademark Rights (as defined below) as security for certain obligations owing by Grantor to Agent, including the Trademark set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on May 19, 2004, at Reel 2969, Page 0381; and

WHEREAS, Grantor has requested that Agent release its security interest in the Trademark and Trademark Rights.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Grantor’s right, title and interest in and to the following (collectively the “**Trademark Rights**”):


(a) each trademark listed on Schedule 1 annexed hereto, and all of the goodwill of the business connected with the use of, and symbolized by, such trademark; and
