TRADEMARK ASSIGNMENT AGREEMENT

- Parties; Effective Date.** This Trademark Assignment Agreement ("Agreement") is entered into between Accurate Metal Holding, LLC, a Delaware limited liability company ("Assignor") and Accurate Metal Solutions, LLC, a Delaware limited liability company ("Assignee"). This Agreement is made pursuant to an Asset Contribution Agreement, dated May 11, 2012, and is effective as of that date.
- Purpose of Agreement.** Assignor is the owner of the mark, METALURGENCY, U.S. Registration No. 2,860,174 (the "Mark"), and seeks to assign to Assignee, and Assignee seeks to acquire, the Mark pursuant to this Agreement.
- Assignment of Mark.** For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns, sells, transfers and conveys all right, title and interest in and to the Mark, including, without limitation: (a) all goodwill associated with the Mark, and all goodwill associated with the goods to which the Mark pertains; (b) the U.S. Application for the Mark; and (c) any and all other rights, whether statutory or common law, corresponding thereto and all other rights of any kind whatsoever accruing thereunder, together in each case with the goodwill of the business connected with the use of, and symbolized by the Mark.
- Binding Effect.** This Agreement shall be binding upon and inure to the benefit of the parties' heirs, representatives, successors, and assigns.
