**REASSIGNMENT AND  
RELEASE OF TRADEMARKS AND  
TERMINATION OF TRADEMARK SECURITY AGREEMENT**

This Reassignment and Release of Trademarks and Termination of Trademark Security Agreement dated August 22, 2012 and effective as of June 11, 1999 (this "Release") is made by Wells Fargo Bank, successor in interest to SouthTrust Bank of Alabama, acting in its capacity as secured party (in such capacity, the "Secured Party"), in favor of Red Diamond, Inc., and Donovan Coffee Company, Inc. (collectively, the "Debtor").

WITNESSETH

WHEREAS, pursuant to that certain Collateral Patent, Trademark, Copyright and License Assignment, dated as of January 3, 1991, recorded in the records of the United States Patent and Trademark Office on January 28, 1991 beginning at Reel 0762, Frame 0731 from the Debtor in favor of Secured Party (the "Security Agreement"), the Debtor granted to Secured Party, among other things, a continuing security interest in Debtor's trademarks, trademark applications, claims arising out of or relating thereto, general intangibles associated therewith, and all proceeds of the foregoing (including, without limitation, the trademarks set forth on Schedule A attached hereto) (the "Debtor Trademarks") by means of assignment;

WHEREAS, the Secured Party wishes to reassign the Debtor Trademarks and release its security interest in the Debtor Trademarks and terminate the Security Agreement in the records of the United States Patent and Trademark Office;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party does hereby reconvey and reassign to Debtor the Debtor Trademarks and does hereby release, without recourse, representation or warranty, its security interest solely in, to or under the Debtor Trademarks, together with the goodwill of the business solely to the extent symbolized thereby and does hereby terminate the Security Agreement.




This Release shall be governed in all respects by the laws of the State of Alabama.

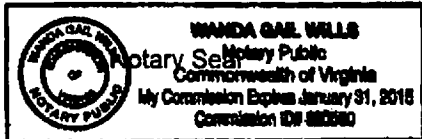
