## RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE AND REASSIGNMENT OF TRADEMARKS dated August <sup>24</sup>, 2012, by BMO Harris Bank N.A., a national banking association formerly known as Harris N.A. formerly known as Harris Trust and Savings Bank (the "*Secured Party*"), with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603;

### WITNESSETH:

WHEREAS, Fantasy Diamond Corporation, an Illinois corporation (the "*Debtor*") with its principal place of business and mailing address at 1550 West Carroll Avenue, Chicago, Illinois, and the Secured Party were parties to a Trademark Collateral Agreement dated as of September 1, 2004, between the Debtor and the Secured Party which was recorded in the United States Patent and Trademark Office on September 9, 2004, at Reel 002934, Frame 0178, and a Trademark Collateral Agreement dated as of November 30, 2006, between the Debtor and the Secured Party which was recorded in the United States Patent and Trademark Office on December 1, 2006, at Reel 003436, Frame 0824 (the "*Agreements*"), pursuant to which the Debtor granted to the Secured Party, a security interest in and collateral assignment of, among other things, the trademarks, trademark registrations, and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the "*Trademark Property*"); and

WHEREAS, the Debtor has requested that the Secured Party release its security interests in the Trademark Property and reassign the same to the Debtor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

The Secured Party hereby releases its security interests in and collateral assignment of, and reassigns, grants and conveys to the Debtor, without any representation, warranty, recourse or undertaking by the Secured Party, all of its right, title and interest, if any, in and to:


(i) Each trademark, trademark registration and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration and trademark application; and

(ii) All proceeds of the foregoing, including without limitation any claim by the Debtor against third parties for damages by reason of past, present or future infringement of any trademark or trademark registration listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, or trademark registration, in each case together with the right to sue for and collect said damages.
