RELEASE OF TRADEMARK SECURITY INTEREST

Bentley Prince Street, Inc., a corporation organized and existing under the laws of the State of Delaware, having an address at 14641 E. Don Julian Road, City of Industry, CA 91746 (“Assignor”), entered into (i) that certain Assignment of Security Interest and Amendment to Trademark Security Agreement, dated as of June 3, 2009, between Assignor, SunTrust Bank and Wells Fargo Bank, N.A. 
