**CONFIRMATION OF
ASSIGNMENT OF INTELLECTUAL PROPERTY ASSETS**

THIS CONFIRMATION OF ASSIGNMENT OF INTELLECTUAL PROPERTY ASSETS (this "Confirmation of Assignment") is executed and delivered to NTS Acquisition Corp., a Delaware corporation (the "Assignee") as of May 29th, 2012, by ThermoSpas, Inc., a Connecticut corporation (the "Assignor"). Capitalized terms used and not defined herein shall have the meanings ascribed thereto in that certain Asset Purchase Agreement (the "Asset Purchase Agreement"), dated as of March 19th, 2012, by and between the Assignee and the Assignor, as amended by the Modification and Supplement Agreement, dated as of May 3rd, 2012, and that Second Modification and Supplement Agreement, dated as of May 29th, 2012, by and between the Assignee and the Assignor.

RECITALS

A. Pursuant to the Asset Purchase Agreement, the Assignor agreed to sell, convey, assign, transfer and deliver to the Buyer and the Buyer agreed to purchase and acquire from the Assignor, free and clear of all liens, all the Assignor's right, title and interest in and to certain assets of the Assignor used in the conduct of the business, including, without limitation, the Intellectual Property; and

B. The Assignor desires to transfer and assign to the Assignee, and the Assignee desires to accept the transfer and assignment of, the Intellectual Property, including, without limitation, the patents, patent applications and registered trademarks identified on Schedule A attached hereto (all of the foregoing being referred to herein as the "Assigned Intellectual Property Assets").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor does hereby assign to the Assignee the Assigned Intellectual Property Assets together with all of the Assignor's right to sue and recover for past, present, and future infringements of the Assigned Intellectual Property Assets (collectively, the "Assigned Property"), free and clear of all liens, the same to have and to hold by the Assignee as fully and entirely as the same would have been held by the Assignor had this assignment not been made.

The Assignor hereby agrees to execute such further documents and to perform such further lawful acts as may reasonably be requested by the Assignee to effect the assignments set forth above and to that end the Assignor will execute all documents for use in applying for and obtaining any patent, trademark and copyright relating to the Assigned Property and other rights and protections and enforcing the same, as the Assignee may reasonably request, together with any assignments thereof to the Assignee or persons designated by it. Further, Assignor, as registrant of certain internet domains used in the Business, shall take all necessary steps to instruct the registrars of said internet domains to transfer the registrations, as well as any and all logon credentials of the internet domains, to Assignee. In the event the Assignee is unable, after reasonable effort, to secure the Assignor's signature on any document or documents needed to apply for or prosecute any patent, trademark, copyright, or other right or protection relating to any Assigned Property, including the internet domains, for any reason whatsoever, the Assignor

hereby irrevocably designates and appoints the Assignee and its duly authorized officers and agents as the Assignor's agent and attorney-in-fact to act for and on the Assignor's behalf to execute and file any such application or applications and to do all other lawfully permitted acts to further the prosecution of any patents, trademarks, copyrights, internet domains, or similar protections relating to the Assigned Property thereon with the same legal force and effect as if executed by the Assignor.

The representations and warranties of Assignor applicable to the Assigned Property, together with all limitations, restrictions, disclaimers and other provisions thereof, are contained in the Asset Purchase Agreement, and are incorporated by reference herein. THIS ASSIGNMENT OF THE ASSIGNED INTELLECTUAL PROPERTY ASSETS DOES NOT, NOR SHALL IT BE DEEMED TO SUPERSEDE, SUPPLANT, EXTINGUISH, MERGE OR EXPAND IN ANY WAY ANY OF THE REPRESENTATIONS, WARRANTIES, INDEMNITIES, COVENANTS, CONDITIONS, OR LIMITATIONS CONTAINED IN THE ASSET PURCHASE AGREEMENT.

This Confirmation Assignment shall be enforced, construed, and performed in accordance with the laws of the State of Connecticut without any effect to the choice of law principles thereof. Assignor and Assignee hereby agree that any suit, action or proceeding arising out of or based upon this Confirmation Assignment shall be instituted against it in the United States Bankruptcy Court for the District of Connecticut (the "Bankruptcy Court").

This Confirmation Assignment may be executed in any number of counterparts (including electronic versions) and each shall be considered an original and together they shall constitute one Assignment.


