7. The authorized capital stock of Inter-Tel Arizona is 100,000,000 shares, all of which are designated Common Stock, no par value.

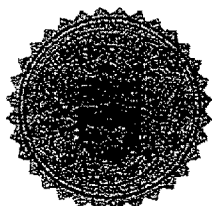
