**TERMINATION AND RELEASE OF  
COLLATERAL ASSIGNMENT OF TRADEMARKS**

This Termination and Release of Collateral Assignment of Trademarks (the "Release") is conveyed as of August 21, 2012, by WELLS FARGO BANK, NATIONAL ASSOCIATION as administrative agent under the Credit Agreement referred to below (in such capacity, the "Administrative Agent"), in favor of the Assignors as identified on Schedule I attached hereto (the "Assignors"). Capitalized terms used herein and not otherwise defined herein shall have the respective meanings provided therefor in the Credit Agreement referred to below.

WHEREAS, Benihana Inc. and Benihana National Corporation (the "Borrowers") entered into that certain Credit Agreement dated as of February 10, 2011 (as amended, amended and restated, or otherwise modified from time to time, the "Credit Agreement") with the lenders from time to time party thereto (collectively, the "Lenders") and the Administrative Agent;

WHEREAS, in connection with the Credit Agreement, the Assignors entered into that certain Security Agreement, dated as of February 10, 2011 (as amended, amended and restated, or otherwise modified from time to time, the "Security Agreement") with the Administrative Agent, pursuant to which the Assignors granted to the Administrative Agent a continuing security interest in favor of the Administrative Agent in and to the trademark registrations and trademark applications listed on Exhibit A;

WHEREAS, in connection with the Security Agreement, the Assignors entered into that certain Trademark Collateral Security and Pledge Agreement, dated February 10, 2011 (as amended, amended and restated, or otherwise modified from time to time, the "Trademark Agreement") with the Administrative Agent, pursuant to which the Assignors granted to the Administrative Agent a continuing security interest in favor of the Administrative Agent in and to the trademark registrations and trademark applications listed on Exhibit A (together with the security interest granted under the Security Agreement, the "Security Interest"), which was recorded with the United States Patent and Trademark Office on February 8, 2011, at Reel 4482, Frame 0387; and

WHEREAS, the Administrative Agent has agreed to terminate and release its Security Interest as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, the Administrative Agent hereby releases, terminates and discharges the Security Interest granted under the Security Agreement and the Trademark Agreement with respect to the trademark registrations and trademark applications listed on Exhibit A, and any right, title or interest of the Administrative Agent in such trademark registrations and trademark applications granted under the Security Agreement and Trademark Agreement shall hereby cease and become void.
