AFFIDAVIT OF WALTER D. HOSP
TO CORRECT ASSIGNMENT RECORDED JULY 30, 2008
FOR THE TRADEMARK PERMEDION IN CLASS 42 (Reg. No. 2,620,140)

I, Walter D. Hosp, having been duly sworn on oath, depose and state that I am over 18 years of age, have personal knowledge of the facts set forth in this Affidavit and, if called as a witness at trial, would testify as follows:

1. On August 2, 2007, Peer Review Systems, Inc. dba Permedion (an Ohio non-profit corporation) and Health Management Systems Acquisition Corporation (a New York corporation) effectuated a certain Asset Purchase Agreement through which Health Management Systems Acquisition Corporation acquired all assets of Peer Review Systems, Inc. dba Permedion.

2. As part of that Asset Purchase Agreement dated August 2, 2007, Health Management Systems Acquisition Corporation acquired all right, title and interest in and to the PERMEDION trademark (Reg. No. 2,620,140)(hereinafter "Mark") together with the goodwill of the business symbolized by the Mark, including all past, current or future causes of action for infringement of the same.


3. On October 1, 2007, the Mark was assigned from Peer Review Systems, Inc. dba Permedion to Health Management Systems Acquisition Corporation.

4. On October 9, 2007, Health Management Systems Acquisition Corporation changed its name with the New York Department of State to Permedion, Inc.

5. On July 30, 2008, to clear up any ambiguities with respect to the chain of title for the Mark, a Trademark Assignment Agreement and corresponding cover sheet, which are located at Reel 3825/Frame 0090, were recorded in connection with the Mark with the Assignments Division of the United States Patent and Trademark Office.

6. The Assignment Agreement and corresponding cover sheet recorded on July 30, 2008 incorrectly list July 25, 2008 as the effective date. The correct effective date of the Assignment was October 1, 2007. Additionally, the Assignment Agreement and corresponding cover sheet recorded on July 30, 2008 incorrectly list Permedion, Inc. as the assignee of the Mark. The correct assignee as of the October 1, 2007 effective date was Health Management Systems Acquisition Corporation which, as referenced above, changed its name to Permedion, Inc. with the New York Department of State on October 9, 2007.

TRADEMARK ASSIGNMENT AGREEMENT

This Agreement (the "Agreement") is entered into by and between Peer Review Systems, Inc. dba Permedion, an Ohio nonprofit corporation ("Assignor"), and Permedion, Inc., a New York corporation ("Assignee") effective as of July 25, 2008.

WHEREAS, Assignor owns all right, title and interest to the following trademark registration (the "Mark"):

1. **PERMEDION**

U.S. Registration No. 2,620,140

WHEREAS, Assignee, or its assigns as permitted hereunder, desires to acquire all right, title and interest in and to the Mark, together with the goodwill associated with the Mark and all past, current or future causes of action for infringement of the same;

NOW, THEREFORE, in consideration of the foregoing recitals and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignor hereby grants, sells, assigns and transfers to Assignee all of the Assignor's right, title and interest in and to the Mark, together with the goodwill of the business symbolized by the Mark, including all past, current or future causes of action for infringement of the same.
2. Assignor hereby authorizes and requests, as appropriate, the United States Patent and Trademark Office to record Assignee as the assignee and owner of the Mark.
3. Assignor represents and warrants to Assignee that it has not heretofore assigned, pledged or otherwise encumbered the Mark, and that the signatory hereto has full power to enter into this agreement and to make the grants herein contained on behalf of Assignor.
4. Assignor hereby agrees to promptly provide to Assignee, its successors, assigns or other legal representatives, reasonable cooperation and assistance at Assignee's reasonable request (including the execution and delivery of any and all documentation as may be reasonably required) in the recordation, implementation or perfection of this Agreement.
5. This is the complete Agreement between the parties with respect to the subject matter contained herein and the parties all intend and agree that this Assignment may not be modified or any waiver of terms claimed unless in writing signed by all parties. This Agreement shall be governed by the laws of the State of New York, exclusive of its conflicts of laws provisions.

6. This Agreement may be executed in counterparts, each of which when taken together shall constitute one and the same original Agreement.
