Section 1 Assignment:

Farber & Partners Inc., solely in its capacity as Court-appointed monitor of the Assignor, in and to each of the trademarks and trademark applications attached hereto as Schedule "A" (the "**Trademarks**"), including any and all goodwill attached thereto, and has agreed to sell, assign and transfer and does hereby sell, assign and transfer unto the said Assignee all of its right, title and interest, in the Trademarks including any and all goodwill or common law rights attached to those registered Trademarks.


This Assignment is in further assurance of an Order made by the Honourable Justice Brown of the Ontario Superior Court of Justice dated February 17, 2012, approving the purchase and sale transaction between the Assignor and the Assignee and vesting certain assets of the Assignor in the Assignee, including the Trademarks (the "**Vesting Order**") and not in substitution thereof. In the event of any inconsistency between the terms of this Assignment and the terms of the Vesting Order, the terms of the Vesting Order shall govern.

A. Farber & Partners Inc., solely in its capacity as Court-appointed monitor of the Assignor, is authorized pursuant to the Vesting Order to execute this Assignment on behalf of the Assignor.

Section 2 Registration:

The Assignor consents to an application to the Registrar of Trademarks for recognition of this transfer.

The Assignor covenants with the Assignee that it will from, time to time, at the request and expense of the Assignee, make, do and execute or cause to be made, done and executed all such further acts, deeds, assurances or things as may reasonably be required by the Assignee for more effectually and completely implementing or carrying out this Assignment, including the registration of the transfer of title of the Trademarks in all jurisdictions.

Section 4 Successors and Assigns:

This Assignment shall enure to the benefit of the Assignee and its successors and assigns and shall be binding upon the Assignor and its respective successors and assigns.

Section 5 Governing Law:

This Assignment shall be governed and interpreted in accordance with the laws of the Province of Ontario and the federal laws of Canada applicable therein.

Section 6 Counterparts:

This Assignment may be executed in any number of counterparts and all such counterparts taken together shall be deemed to constitute one and the same instrument.

Section 7 Assignee Acceptance:

The Assignee hereby accepts this Assignment.

Section 8 Representative for Service:


