INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT ("Assignment"), dated as of August 28, 2012, is made by and between Neverblue Communications, Inc. ("Neverblue") and Global Wide Media, Inc. ("Purchaser").

WHEREAS, Neverblue, Neverblue Holdings Limited Partnership, 3091224 Nova Scotia Company, GWM Holdings, Inc., 3265581 Nova Scotia Limited (as assignee of GWM Holdings, Inc.), Neverblue Holdings, Inc. (as assignee of GWM Holdings, Inc.), Global Wide Media, Inc. (as assignee of GWM Holdings, Inc.) and Purchaser (as assignee of GWM Holdings, Inc.) entered into that certain Asset and Securities Purchase Agreement dated July 25, 2012 (as amended, the "Purchase Agreement"), pursuant to which Neverblue agreed to sell, convey, transfer, assign and deliver the Transferred Intellectual Property (as defined in the Purchase Agreement), including all rights to sue or otherwise claim for past, present or future infringement or unauthorized use or disclosure or breach thereof, to Purchaser, and the present Assignment confirms and effectuates the foregoing agreement. Capitalized terms used herein and not otherwise defined herein shall have the respective meanings set forth in the Purchase Agreement;

WHEREAS, Neverblue is the owner of all right, title, and interest in and to the Transferred Intellectual Property, including the intellectual property identified on Schedule I attached hereto, free and clear of all Liens, claims and interests, other than Permitted Exceptions; and

WHEREAS, Purchaser desires to purchase, acquire and accept from Neverblue the Transferred Intellectual Property.

NOW, THEREFORE, in consideration of the premises and covenants set forth herein and in the Purchase Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Neverblue hereby assigns to Purchaser all of Neverblue's right, title and interest in and to all of the Transferred Intellectual Property, including, without limitation, the intellectual property identified on Schedule I attached hereto, together with Neverblue's rights in and to: the trademarks, trade names, service marks, service names, brands, trade dress and logos of Neverblue together with the goodwill associated therewith; the common law rights and trademark registrations for the Transferred Intellectual Property; and all causes of actions, claims, and rights to damages or profits, arising by reason of past, present and future infringements of the Transferred Intellectual Property or injury to the goodwill associated with the Transferred Intellectual Property, including all of Neverblue's rights to sue or otherwise claim and collect such damages for past, present or future infringement or unauthorized use or disclosure or breach thereof, free and clear of all Liens, claims and interests, other than Permitted Exceptions.

2. This Assignment has been executed and delivered by Neverblue with the agreement that the same may be recorded with the United States Patent and Trademark Office and in other jurisdictions outside the United States. The parties shall cooperate to execute and deliver such other documents and take all such other actions as reasonably necessary to effect the intent hereof.

3. In the event Purchaser is unable for any reason, after reasonable effort, to secure Neverblue's signature on any document needed in connection with the actions specified in Section 2 above, Neverblue hereby irrevocably designates and appoints Purchaser and its duly authorized officers and agents as Neverblue's agent and attorney-in-fact solely with respect to the matters specified in Section 2 above, and such appointment is coupled with an interest to act for and on Neverblue's behalf to execute, verify and file any such documents and to do all other lawfully permitted acts to further the purposes of Section 2 above with the same legal force and effect as if executed by Neverblue.

4. This Assignment may be executed in counterparts, each of which shall be deemed to be an original, and all of which together shall constitute one and the same instrument. This Assignment along with Schedule I and together with the Purchase Agreement constitute the entire understanding and agreement of the parties hereto with respect to the subject matter hereof and supersede all prior and contemporaneous agreements or understandings, inducements or conditions, express or implied, written or oral, between and among the parties with respect hereto. In the event of any conflict between the terms of this Assignment and the terms of the Purchase Agreement, the terms of the Purchase Agreement shall control. This Assignment may not be supplemented, altered, or modified in any manner except by a writing signed by all parties hereto. The failure of any party to enforce any terms or provisions of this Assignment shall not waive any of its rights under such terms or provisions. This Assignment shall bind and inure to the benefit of the respective parties and their permitted assigns and successors.

5. This Assignment and any claim related directly or indirectly to this Assignment shall be governed by and construed in accordance with the laws of the State of New York, without regard to the principles of conflicts of law thereof that would defer to the substantive laws of any other jurisdiction. The parties agree that, during the period from the date hereof until the date on which the Bankruptcy Case is closed or dismissed (the "Bankruptcy Period"), the Bankruptcy Court shall have exclusive jurisdiction to resolve any controversy, claim or dispute arising out of or relating to this Assignment or any other agreement entered into in connection herewith. The parties further agree that, following the Bankruptcy Period, any action or proceeding with respect to such controversy, claim or dispute shall be brought against any of the parties exclusively in either the United States District Court for the Southern District of New York or any state court of the State of New York located in such district, and each of the parties hereby consents to the personal jurisdiction of such court and the Bankruptcy Court (and to the appropriate appellate courts) in any such action or proceeding and waives any objection, including, without limitation, any objection to the laying of venue or on the grounds of forum non conveniens, which any of them may now or hereafter have to the bringing of

such action or proceeding in such respective jurisdictions. Each party hereby irrevocably consents to the service of process of any of the aforesaid courts in any such action or proceeding by the mailing of copies thereof by registered or certified mail, postage prepaid, to the other parties to such action or proceeding. Each party acknowledges and agrees that any controversy which may arise under this Assignment is likely to involve complicated and difficult issues, and therefore each party hereby irrevocably and unconditionally waives any right such party may have to a trial by jury.

6. This Assignment is not intended, and shall not be deemed, to confer upon or give any person (including, without limitation, any past or current business employee) except the parties hereto and their respective successors and permitted assigns, any remedy, claim, liability, reimbursement, cause of action or other right under or by reason of this Assignment.

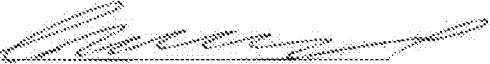
