ASSIGNMENT OF INTELLECTUAL PROPERTY

This ASSIGNMENT OF INTELLECTUAL PROPERTY (this "*Assignment*") is dated and made as of March 30, 2012 by and between Hana LLC, a Colorado limited liability company ("*Assignor*"), and Tronics Acquisition LLC, a Delaware limited liability company ("*Assignee*").

WHEREAS, Assignor is the owner of certain Company Intellectual Property used in connection with its Business, including, without limitation, any and all of the following and all rights in, arising out of or associated therewith throughout the world, including any registrations or applications therefor: (i) all United States and foreign patents and applications therefor and all reissues, divisions, renewals, extensions, provisionals, continuations and continuations-in-part thereof; (ii) all inventions (whether patentable or not), invention disclosures, improvements, trade secrets, proprietary information, know how, schematics, technology, process and manufacturing information, research and development data, technical data and customer lists, and all documentation relating to any of the foregoing; (iii) all United States and foreign copyrights, copyrights registrations and applications therefor and all other rights corresponding thereto; (iv) all United States and foreign mask works, mask work registrations and applications therefor; (v) all United States and foreign industrial designs and any registrations and applications therefor; (vi) all United States and foreign trade names, logos, slogans, common law trademarks and service marks; trademark and service mark registrations and applications therefor and all goodwill associated therewith; (vii) all databases and data collections and all rights therein; and (viii) all computer software including all source code (whether or not deployed), object code, firmware, development tools, files, records and data, all media on which any of the foregoing is recorded, all Internet addresses, uniform resource locators, sites (and all content contained therein) and domain names; (ix) any similar, corresponding or equivalent rights to any of the foregoing; and (x) the intangible property set forth on Schedule A attached hereto, together with sufficient documentation related to the operation of any of the foregoing such that Assignee is able to understand such Intellectual Property and to use and operate such Intellectual Property following the Closing in the same manner as such Intellectual Property is being used by the Company as of the date of this Agreement; and

WHEREAS, pursuant to that certain Asset Purchase Agreement, dated as of March 19, 2012, by and among Assignor, Assignee and Brett Mosley (the "*Asset Purchase Agreement*"), Assignor has agreed to sell, transfer, assign and deliver to Assignee, and Assignee has agreed to purchase from Assignor, all of Assignor's rights, title and interest in, to and under the Acquired Assets used in connection with Assignor's Business, including, without limitation, all Company Intellectual Property relating to the operation of the Business.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the parties hereto agree as follows:

1. Capitalized terms used but not otherwise defined herein shall have the meanings for such terms that are set forth in the Asset Purchase Agreement.

2. Assignor has, subject to Section 5 hereof, assigned and does hereby sell, transfer, assign and deliver unto Assignee its entire right, title and interest in and to all existing Company Intellectual Property, including, without limitation, the right to recover for past infringement of said Company Intellectual Property and the goodwill of the business in connection with which said Company Intellectual Property is used and which is symbolized by said Company Intellectual Property.

3. Assignor hereby represents that the execution, delivery and performance of this Assignment by Assignor has been duly and validly authorized by all necessary company action, that this Assignment has been duly and validly executed and delivered by Assignor and that this Assignment constitutes a valid and legally binding agreement of Assignor, enforceable against Assignor in accordance with its terms, except as such enforceability may be limited by applicable bankruptcy, insolvency, reorganization, moratorium or other laws affecting the enforcement of creditors rights generally and general principles of equity (regardless of whether such enforceability is considered in a proceeding in law or equity). Assignor, including its officers, managers, employees and representatives, acknowledges and agrees that it will not, directly or indirectly, challenge the ownership, validity or enforceability of any of the Company Intellectual Property assigned herein.

4. Assignor hereby covenants and represents that the execution, delivery and performance of this Assignment does not conflict with, result in a breach of or constitute a default under any applicable law, judgment, order, injunction, decree, rule or regulation, or ruling of any court or governmental instrumentality, or the articles of organization or operating of Assignor, or conflict with, constitute grounds for termination of or result in a breach of or constitute a default under any agreement, instrument, license or permit to which Assignor is or will be subject.

5. Assignor hereby further covenants and agrees that Assignor will communicate to Assignee and its officers, managers, employees, representatives, successors and assignees any facts known to Assignor respecting the Company Intellectual Property and, at Assignee's sole expense, will testify in any legal proceeding, sign all lawful papers, execute all applications for registration, make all rightful oaths and generally do everything possible to aid Assignee and its officers, managers, employees, representatives, successors and assignees to obtain and enforce proper ownership of and protection for the Company Intellectual Property in all countries. Assignor agrees to execute and deliver, upon Assignee's reasonable request, any additional assignments and/or other appropriate documentation, and undertake such additional acts, as Assignee deems to be reasonably necessary to effect the transfer of the Company Intellectual Property to Assignee as set forth in Section 2. In the event that Assignee is unable for any reason whatsoever to secure the signature of Assignor to any document Assignor is required to execute pursuant to this Section 5, Assignor hereby irrevocably designates and appoints Assignee, and its duly authorized officers and agents, as its agents and attorneys-in-fact to act for and on its behalf to execute and/or file and such document and to take any other lawfully permitted action to further the purposes of this Section 5 with the same legal force and effect as if executed and taken by Assignor.

6. Assignor and Assignee agree that this Assignment shall be effective as of the Closing Date.

7. Notwithstanding any other provisions of this instrument to the contrary, nothing contained herein shall in any way supersede, modify, replace, amend, change, rescind, waive, exceed, expand, enlarge or in any way affect the provisions, including representations and warranties, covenants, agreements, conditions or, in general, any of the rights and remedies, and any of the obligations, of Assignor or Assignee set forth in the Asset Purchase Agreement, including, without limitation, any indemnification specified therein. This Assignment is subject to, and controlled by, the terms of the Asset Purchase Agreement.

8. This Assignment shall be governed by and construed in accordance with the laws of the State of Delaware applicable to a contract executed and performed in such state, without giving effect to the conflicts of laws principles thereof. Each of Assignor and Assignee irrevocably consents to the exclusive jurisdiction of any court located within the State of Delaware in connection with any matter based upon or arising out of this Agreement or the matters contemplated hereby and it agrees that process may be served upon it in any manner authorized by the laws of the State of Delaware for such persons and waives and covenants not to assert or plead any objection which it might otherwise have to such jurisdiction and such process.

9. This Assignment shall not be amended, supplemented or modified except by an agreement in writing that is signed by the parties hereto.

10. The headings contained in this Assignment are intended solely for convenience and shall not affect the rights of the parties to this Assignment.

11. This Assignment may be executed in two counterparts, each of which shall constitute an original and all of which together shall constitute one and the same document. Facsimile and other electronically scanned signatures of the parties hereto shall be binding.
