ASSIGNMENT AND ASSUMPTION OF TRADEMARKS

NOW THEREFORE, in consideration of the Purchase Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

- 1. <u>Definitions</u>. For purposes of this Assignment and Assumption of Trademarks, capitalized terms shall have the meaning set forth in the body of this Assignment and Assumption of Trademarks or in the Purchase Agreement.
- 2. <u>Assignment.</u> Assignor does hereby irrevocably sell, assign, convey and transfer to Assignee all of its worldwide right, title and interest in and to the Assigned Trademarks and all goodwill pertaining to the Assigned Trademarks. The foregoing assignment of the Assigned Trademarks includes the exclusive rights to (a) apply for and maintain all registrations, issuances, renewals and extensions thereof, (b) bring actions or otherwise recover for past, present and future infringements thereof, (c) grant licenses or other interests therein, (d) receive all income royalties, damages and other payments now and hereafter due and/or payable with respect thereto (including, without limitation, payments under all licenses entered into in connection therewith, and damages and payments for past, present or future infringements thereof) and (e) all other rights of any kind whatsoever of Assignor accruing thereunder or pertaining thereto.
- 3. <u>No Third Party Beneficiaries</u>. Nothing in this Assignment and Assumption of Trademarks, express or implied, is intended to or shall confer upon any other Person or Persons (including, without limitation, any employee or collective bargaining representatives thereof) any rights, benefits or remedies of any nature whatsoever under or by reason of this Assignment and Assumption of Trademarks.
 - 4. Further Assurances. Assignor shall provide to Assignee, its successors,

assigns or other legal representatives, cooperation and assistance at Assignee's reasonable request and expense (including, without limitation, the execution and delivery of any and all affidavits, declarations, oaths, samples, exhibits, specimens and other documentation) as may be reasonably required to implement, record or perfect this Assignment and Assignee's interest in and to the Trademarks.

- 5. <u>Binding Effect</u>; <u>Assignment</u>. This Assignment and Assumption of Trademarks shall be binding upon and inure solely to the benefit of the parties hereto and their respective successors (whether by operation of law or otherwise) and assigns.
- 6. Governing Law. This Assignment and Assumption of Trademarks, including all matters of construction, validity and performance, shall be governed by and construed in accordance with the laws of the State of New York without regard to the principles of conflicts or choice of laws or any other law that would make the laws of any other jurisdiction other than the State of New York applicable hereto.
- 7. <u>Counterparts</u>; Facsimile Signatures. This Assignment may be executed in any number of counterparts, each of which shall be deemed to be an original, and all of which together shall constitute one and the same instrument. This Agreement may be executed and delivered by facsimile or electronic transmission and upon such delivery the facsimile or electronic counterparts will be deemed to have the same effect as if the original signature had been delivered to the other party.


