**RELEASE OF SECURITY INTEREST
IN UNITED STATES TRADEMARKS**

This RELEASE OF SECURITY INTEREST (the "Release"), effective as of August 29, 2012, is granted by DEUTSCHE BANK TRUST COMPANY AMERICAS (formerly known as BANKERS TRUST COMPANY), with offices at 60 Wall Street, New York, New York, 10005, as Collateral Agent (the "Collateral Agent") to COLTEC INDUSTRIES INC (the "Grantor"), as follows:

WHEREAS, the Grantor has heretofore granted to the Collateral Agent a security interest in certain United States trademark registrations and trademark applications more particularly set forth on Schedule A attached hereto (collectively, the "Marks") pursuant to the Assignment for Security in U.S. Trademarks dated March 16, 1998, between Grantor and Collateral Agent (the "Assignment for Security") to secure the Obligations as such term is defined in the Security Agreement dated as of December 18, 1996, between Collateral Agent and Grantor (as amended, modified, restated or supplemented from time to time); and

WHEREAS, the Collateral Agent wishes to release and restore all rights, title, and interest in and to the Marks to the Grantor and to dissolve any and all liens and encumbrances with respect to the Marks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Collateral Agent hereby releases, discharges, quit claims and relinquishes unto the Grantor any and all right, title, and interest in and to the Marks (and any proceeds, claims or goodwill associated with, or arising from, the Marks) without representation or warranty of any kind, and more particularly, the security interest in the Marks granted to the Collateral Agent by the Grantor pursuant to the Assignment for Security, which security interest

was recorded on November 2, 1998, at Trademark Reel Frame 1808/0561-0564 in the United States Patent and Trademark Office.
