**TERMINATION AND RELEASE OF SECURITY  
INTEREST IN TRADEMARKS**

WHEREAS, Symphony Teleca Services, Inc., fka Symphony Service Corp. ("Debtor"), a Delaware corporation, granted a security interest in certain collateral (as hereinafter described) to Silicon Valley Bank ("Secured Party") under the Intellectual Property Security Agreement dated April 26, 2004 (the "Security Agreement"); and

WHEREAS, the security interest was recorded in the Trademark Division of the United States Patent and Trademark Office on the dates and at the Reels and Frames specified on the attached Schedule 1; and

Secured Party hereby releases and terminates the security interest granted pursuant to the Security Agreement in, to and under all of the Debtor's trademark registrations listed on Schedule 1 attached hereto, and made a part hereof (collectively, the "Trademarks"), which Trademarks have been registered with the United States Patent and Trademark Office.

2. Secured Party hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States, to record the release and termination of the Security Interest in the Trademarks by Secured Party.
