Seller also hereby assigns to Buyer all income, royalties, and payments due to Seller with respect to the foregoing assigned Trademarks, including, without limitation, unpaid damages for past, present and future claims for infringement of the assigned Trademarks.

Seller hereby authorizes and requests the officials of the United States Patent and Trademark Office and the corresponding officials of any and all other countries worldwide to issue any and all trademark registrations for the Trademarks, when granted, to Buyer, as buyer of Seller's entire right, title and interest in and to the same, for the sole use and benefit of the Buyer, its successors and assigns.

Seller also agrees that it will reasonably cooperate with Buyer to fully carry out the terms of this assignment and that it will promptly sign and/or deliver to Buyer all documents which may be reasonably necessary to record this assignment and any prior assignments or other transfers of ownership of the Trademarks in any country of the world and otherwise perfect Buyer's ownership of the Trademarks.

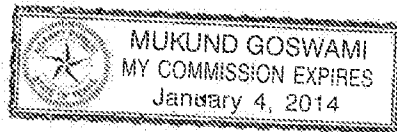
