Pursuant to Title 8, Section 264(c) of the Delaware General Corporation Law and Title 6, Section 18-209 of the Delaware Limited Liability Company Act, the undersigned have executed the following Certificate of Merger:

FIRST: The name of the surviving Delaware limited liability company is Myobloc, LLC, and the name of the Delaware corporation being merged into this surviving limited liability company is Solstice Neurosciences, Inc.
