GRANT OF SECURITY INTEREST IN TRADEMARKS

September 7, 2012

Pursuant to the Credit Agreement dated as of September 7, 2012, (together with all amendments, restatements, supplements or other modifications thereto, the "Credit Agreement") among PMFG, INC., a Delaware corporation ("PMFG"), and PEERLESS MFG. CO., a Texas corporation ("Peerless", and PMFG and Peerless, individually and collectively shall be referred to herein as, the "Borrower"), CITIBANK, N.A., a national banking association, as Administrative Agent, and the other agents and lenders (the "Lenders") which are or become parties thereto, and pursuant to the Security Agreement dated as of September 7, 2012, (as the same may be amended, modified, extended or restated from time to time, the "Security Agreement") by and among each Grantor party thereto and CITIBANK, N.A., a national banking association, as administrative agent ("Administrative Agent") for the benefit of itself and the Secured Creditors referenced therein ("Secured Creditors"), each of the undersigned has granted a continuing security interest in and continuing lien upon all of its trademarks and trademark applications to the Administrative Agent for the ratable benefit of the Administrative Agent and the Secured Creditors. Capitalized terms not otherwise defined herein have the meaning specified in the Security Agreement.

Furthermore, as security for the payment and performance, as the case may be, in full of the Obligations (as defined in the Credit Agreement), when due, whether at stated maturity, by acceleration or otherwise, the undersigned hereby assign to, and pledge and grant to Administrative Agent, for the benefit of itself and each other Secured Creditor, a security interest in the entire right, title, and interest in and to the following property, whether now owned or hereafter acquired or existing (the "Trademark Collateral"):


