NOTICE OF RELEASE OF SECURITY INTEREST

This Notice of Release of Security Interest (the "Release") is effective as of September 7, 2012, by Wells Fargo Bank, National Association (successor by merger to Wachovia Bank, National Association), a national banking association (together with its successors, "Secured Party").

NOW, THEREFORE, intending to be legally bound hereby and in connection with the Security Agreements, Secured Party hereby releases and remits, without any recourse, representation or warranty, any and all rights, title and interests in and to the Trademarks, and hereby authorizes the Grantors or Grantors' authorized representative to record this Release with the United States Patent and Trademark Office as evidence of such release.
