CERTIFICATE OF MERGER

OF

Cbr Systems, Inc.
(a California corporation)

WITH AND INTO

CBR Systems Reincorporation Sub, Inc.
(a Delaware corporation)

CBR Systems Reincorporation Sub, Inc., a corporation organized and existing under the laws of Delaware, hereby certifies that:

1. The name and state of incorporation of each of the constituent corporations are:

(a) Cbr Systems, Inc., a California corporation ("*Cbr Systems California*"); and

(b) CBR Systems Reincorporation Sub, Inc., a Delaware corporation ("*Cbr Systems Delaware*").

2. An Agreement and Plan of Merger, dated as of December 12, 2011 (the "*Merger Agreement*"), has been approved, adopted, certified, executed and acknowledged by each of Cbr Systems California and Cbr Systems Delaware in accordance with the provisions of subsection (c) of Section 252 of the General Corporation Law of the State of Delaware.

3. The surviving corporation is Cbr Systems Delaware whose name is changed to Cbr Systems, Inc. (the "*Surviving Corporation*").

4. The Certificate of Incorporation of Cbr Systems Delaware shall be the Certificate of Incorporation of the Surviving Corporation except that Article I of the Restated Certificate of Incorporation of the Surviving Corporation is hereby amended in its entirety to read as follows:

ARTICLE I

The name of this corporation is Cbr Systems, Inc. (the "*Corporation*")."

5. The executed Merger Agreement is on file at the principal place of business of the Surviving Corporation at 1200 Bayhill Road, San Bruno, California 94066.

6. A copy of the Merger Agreement will be furnished by the Surviving Corporation, on request and without cost, to any shareholder of Cbr Systems California or stockholder of Cbr Systems Delaware.

7. The authorized capital stock of Cbr Systems California is 63,110,118 shares, including 50,000,000 shares of Common Stock, \$0.001 par value per share, and 13,110,118

shares of Preferred Stock, \$0.001 par value per share, of which (i) 1,866,273 shares are designated Series A Preferred Stock, (ii) 2,677,376 shares are designated Series C Preferred Stock and (iii) 6,024,097 shares are designated Series D Preferred Stock.

8. This Certificate of Merger shall become effective on December 23, 2011 as filed with the Secretary of State of the State of Delaware.

IN WITNESS WHEREOF, CBR Systems Reincorporation Sub, Inc. has caused this certificate to be signed by the undersigned officer, thereunto duly authorized, on December 23, 2011.
