PATENT AND TRADEMARK SECURITY AGREEMENT

THIS PATENT AND TRADEMARK SECURITY AGREEMENT (this "Agreement") is entered into as of July 20, 2012 by Poof-Slinky, Inc., a Michigan corporation (the "Grantor"), in favor of JPMorgan Chase Bank, N.A., a national banking association (the "Lender").

Recitals

A. The Grantor and the other Loan Parties party thereto from time to time entered into a Credit Agreement dated as of July 20, 2012 (as amended, supplemented, restated or otherwise modified from time to time, the "Credit Agreement") with the Lender pursuant to which the Lender made available to the Grantor credit facilities.

B. In connection with the Credit Agreement, the Grantor and Poof-Slinky Holdings, LLC entered into a Pledge and Security Agreement dated as of July 20, 2012 (as amended, supplemented, restated or otherwise modified from time to time, the "Security Agreement"), pursuant to which certain Secured Obligations owed to the Lender are secured.

C. Pursuant to the terms of the Security Agreement, the Grantor pledged, assigned and granted to the Lender a first-priority security interest (subject to Liens permitted by the Loan Documents) in substantially all of the assets of the Grantor, including all right, title and interest of the Grantor in, to and under all now owned and hereafter acquired Patents and Trademarks (as defined in the Security Agreement) to secure the prompt and complete payment and performance of the Secured Obligations under the Credit Agreement.

D. Pursuant to the terms of the Security Agreement, the Grantor is required to execute and deliver to the Lender, this Agreement.

Agreement

In consideration of the recitals set forth above and the mutual agreements contained herein and in the Credit Agreement and the other Loan Documents, the Grantor hereby grants to the Lender, to secure the Secured Obligations, a continuing security interest in all of the Grantor's right, title and interest in, to and under the following, whether now owned by or owing to, or hereafter acquired by or arising in favor of the Grantor (including any trade name or derivations thereof):

- (1) each Patent (as defined in the Security Agreement) owned by Grantor, including, without limitation, each patent and patent application in the United States referred to in Schedule 1 attached hereto, together with any renewal, reissue, division, continuation, continuation-in-part and extension thereof;
- (2) each Patent license to which the Grantor is a party;
- (3) all products and proceeds of the foregoing, including, without limitation, any and all claims by the Grantor against third parties for past, present or future infringement of any Patent owned by Grantor, including, without limitation, any patent referred to in Schedule 1 attached hereto, any patent issued pursuant to a

patent application referred to in Schedule 1 attached hereto and any license of a Patent listed on Schedule 1 attached hereto (items 1 through 3 being herein collectively referred to as the "Patent Collateral");


- (4) each Trademark (as defined in the Security Agreement) owned by Grantor, including without limitation, each trademark registration and trademark application in the United States referred to in Schedule 2 attached hereto, together with any renewals thereof and all goodwill associated therewith;
- (5) each Trademark license to which Grantor is a party, together with all goodwill associated therewith; and
- (6) all products and proceeds of the foregoing, including without limitation, any claim by the Grantor against third parties for past, present or future infringement of any Trademark owned by Grantor, including without limitation, any trademark registration referred to in Schedule 2 attached hereto, any trademark registration issued pursuant to a trademark application referred to in Schedule 2 and any license of a Trademark listed on Schedule 2 attached hereto (items 4 through 6 being herein collectively referred to as the "Trademark Collateral").

The security interests granted to the Lender herein are granted in furtherance, and not in limitation of, the security interests granted to the Lender pursuant to the Security Agreement; provided, however, that nothing in this Agreement shall expand, limit or otherwise modify the security interests granted in the Security Agreement. Grantor acknowledges and affirms that the rights and remedies of the Lender with respect to the security interest in the Patent Collateral and Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Security Agreement, the terms of the Security Agreement shall govern. All capitalized terms used but not defined herein shall have the respective meanings ascribed thereto in the Credit Agreement.
