## Release of Lien on and Security Interest in Trademarks

This Release of Lien on and Security Interest in Trademarks (this "Release"), dated as of August 23, 2012, is made by BANK OF AMERICA, N.A., in its capacity as Administrative Agent for the Secured Parties pursuant to the Credit Agreement (in such capacity, the "Administrative Agent") in favor of ARCHSTONE COMMUNITIES LLC ("Grantor"). All terms used but not otherwise defined herein shall have the meanings ascribed to those terms in the Credit Agreement or Collateral Agreement (as such terms are defined below).

WHEREAS, pursuant to that certain Amended and Restated Credit Agreement, dated as of March 31, 2009 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among Administrative Agent, Archstone Multifamily Holdings I (Development Borrower) LP (f/k/a Tishman Speyer Archstone-Smith Multifamily Holdings I (Development Borrower), L.P.), and the other parties thereto;

WHEREAS, pursuant to the Credit Agreement, the Grantor and certain affiliates thereof entered into that certain Amended and Restated Second Lien Guarantee and Collateral Agreement (ASOT), dated as of March 31, 2009 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Collateral Agreement");

WHEREAS, pursuant to (a) the Collateral Agreement and (b) that certain Grant of Security Interest in Trademarks, dated as of March 31, 2009, by Grantor in favor of Administrative Agent for the Secured Parties (the "Trademark Security Agreement"), Grantor assigned and transferred and granted to the Administrative Agent for the ratable benefit of the Secured Parties a security interest in the Trademarks now owned or at any time thereafter acquired by the Grantor or in which the Grantor then had or at any time in the future may have acquired any right, title or interest (including, without limitation, those Trademarks listed on Schedule A hereto) (the "Trademark Collateral");

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on April 2, 2009 at Reel 3980, Frame 0117; and

WHEREAS, the Lenders have unanimously directed the Administrative Agent to release, relinquish and discharge to Grantor any and all security interest in and lien on the Trademark Collateral held by Administrative Agent for the ratable benefit of the Secured Parties.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent agrees, for the benefit of Grantor, as follows:

1. The Administrative Agent, for itself and the Secured Parties, hereby terminates the Trademark Security Agreement and hereby terminates, releases, cancels, relinquishes and discharges to the Grantor, without representation, warranty or recourse, all liens and security interests the Administrative Agent has in, to and under the Trademark Collateral.

2. **THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK APPLICABLE TO CONTRACTS EXECUTED IN AND TO BE PERFORMED IN SUCH STATE, IRRESPECTIVE OF ITS CHOICE OF LAW RULES.**
