Release of Lien on and Security Interest in Trademarks

This Release of Lien on and Security Interest in Trademarks (this "Release"), dated as of August 23, 2012, is made by Bank of America, N.A., in its capacity as Administrative Agent pursuant to the Credit Agreement (in such capacity, the "Administrative Agent") in favor of Archstone Communities LLC ("Pledgor"). All terms used but not otherwise defined herein shall have the meanings ascribed to those terms in the Security Agreement (as defined below).

WHEREAS, pursuant to (a) that certain Second Amended and Restated Security Agreement (ASOT), dated as of December 2, 2010, by and among Administrative Agent, Archstone Property Holdings LLC, Archstone Multifamily CM LLC, Pledgor and the other Guarantors party thereto (the "Security Agreement"), and (b) that certain Trademark Security Agreement, dated as of December 2, 2010, by Pledgor in favor of Administrative Agent (the "Trademark Security Agreement"), Pledgor pledged and granted to the Administrative Agent for the benefit of the Secured Parties a lien on and security interest in and to all of Pledgor's right, title and interest in, to and under: (a) the Trademarks listed on Schedule I attached hereto (the "Trademarks"), (b) all Goodwill associated with such Trademarks, and (c) all Proceeds of any and all of the foregoing (other than Excluded Property);

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on December 9, 2010 at Reel 4428, Frame 0729; and

WHEREAS, the Lenders have unanimously directed the Administrative Agent to release, relinquish and discharge any and all security interest in and lien on the Trademarks held by Administrative Agent for the benefit of the Secured Parties.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. The Administrative Agent, for itself and the Secured Parties, hereby terminates the Trademark Security Agreement and hereby terminates, releases, cancels, relinquishes and discharges to the Pledgor, without representation, warranty or recourse, all liens and security interests the Administrative Agent has in, to and under (a) the Trademarks, (b) all Goodwill associated with such Trademarks, and (c) all Proceeds of any and all of the foregoing.
2. THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK APPLICABLE TO CONTRACTS EXECUTED IN AND TO BE PERFORMED IN SUCH STATE, IRRESPECTIVE OF ITS CHOICE OF LAW RULES.
