**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Termination and Release") is dated as of September 10, 2012, from CALIFORNIA BANK & TRUST, formerly ALLIANCE BANK, as agent ("Lender"), to FUTURE DONTICS, INC. ("Grantor").

WHEREAS, Grantor has granted to Lender as security interest in all of Grantor's right, title, and interest in and to each of its intellectual property filings where Alliance Bank was conveyed a security interest in the Trademark Collateral.

WHEREAS, such security interest was recorded with the United States Patent and Trademark Office (SEE SCHEDULE A).

WHEREAS, Grantor has paid all of its outstanding indebtedness to Lender as of June 4, 2010.

WHEREAS, Lender wishes to terminate and release the entirety of its security interest in the Trademark Collateral and to reassign to Grantor all of Lender's right, title and interest in and to the Trademark Collateral.


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Lender hereby agrees as follows:

1. Release of Security Interest. The Lender hereby terminates, discharges and releases any security interest it may have in the Trademark Collateral, and any right, title or interest of the Lender in such Trademark Collateral shall hereby cease and become void.

2. Further Assurances. Lender hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby, all at the sole cost and expense of the Grantor.


