**RELEASE OF SECURITY INTEREST IN TRADEMARK**

Effective as of 7. Sept. 2012, France Alter Eco, a limited company organized and existing under the laws of France with an address of 36 Boulevard de la Bastille, 75012 Paris, France ("France Alter Eco"), hereby releases and terminates its security interest in and any lien upon the trademark ALTER ECO, which is currently registered with the U.S. Patent & Trademark Office ("USPTO") (Reg. No. 3671557) (Ser. No. 77384630) (the "Trademark"), together with the goodwill of the business symbolized by the Trademark and registration thereof in the United States and certain Collateral as defined in that certain Security Agreement between France Alter Eco and Alter Eco Americas, Inc., a Delaware corporation ("Alter Eco Americas") dated as of March 1, 2009 which was entered into in order to secure the obligation of Alter Eco Americas to France Alter Eco under that certain Secured Promissory Note dated as of March 1, 2009.

In furtherance of the foregoing, France Alter Eco also hereby agrees to execute and deliver such termination statements, releases, discharges, or other release documents as Alter Eco Americas may request in order to evidence or further reflect the termination of the security interests and liens of France Alter Eco as described above.

France Alter Eco also hereby authorizes Alter Eco Americas to file (or have filed on its behalf) this Release, and such appropriate amendments or termination statements in respect of any financing statement, notice of security interest, or similar document on file or recorded with the USPTO, including, but not limited to, the Notice of Security Interest recorded as to the Trademark (Reg. No. 3671557) (Ser. No. 77384630) with the USPTO (Reel/Frame No. 3997/0457) on June 2, 2009.
