ARTICLES OF INCORPORATION

OF

SouthData, Inc.

The undersigned, being of the age of eighteen years or more, acting as incorporator of a corporation under the North Carolina Business Corporation Act, hereby adopts and acknowledges as the following Articles of Incorporation for such corporation:

1. The name of the corporation is SouthData, Inc.
2. The period of duration of the corporation is perpetual.
3. The purposes for which the corporation is organized are:
  - (a) to engage in computer data entry and in any lawful act or activity for which corporations may be organized under Chapter 55 of the General Statutes of North Carolina.
4. The corporation shall have authority to issue one hundred thousand (100,000) shares with a par value of One Dollar (\$1.00) per share.
5. The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is One Hundred Dollars (\$100.00) in cash or property of equivalent value.
6. The shareholders of the corporation shall have no preemptive right to acquire additional or treasury shares of the corporation.
7. The address of the initial registered office of the corporation in the State of North Carolina is 1878 Farmbrook Road, Mount Airy, Surry County, North Carolina 27030, and the name of its initial registered agent at such address is Bruce Springthorpe.
8. The number of directors constituting the initial board of directors shall be three (3), and the names and addresses of the persons who are to serve as directors until the first meeting of shareholders, or until their successors be elected and qualify are:


