**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is executed and delivered as of September 12, 2012, by U.S. Bank National Association, as administrative agent for certain banks and other financial institutions or entities (the "Administrative Agent"), in favor of TWINCO ROMAX LLC, a Delaware limited liability company ("Twincor" or "Grantor").

WITNESSETH:

WHEREAS, in connection with that certain Amended and Restated Credit Agreement dated as of March 29, 2012 (as amended, supplemented or modified from time to time, the "Credit Agreement") by and among Twincor, the lenders from time to time party thereto (the "Lenders"), and Administrative Agent, Grantor has executed and delivered that certain Amended and Restated Security Agreement dated as of March 29, 2012 in favor of Administrative Agent, for itself and on behalf of the other Lenders which amended and restated that certain Security Agreement dated as of April 22, 2010 (as so amended and restated, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, a security interest (the "Security Interest") was granted by Grantor to Administrative Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, evidence of the Security Interest granted under the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office ("USPTO") on April 22, 2010, at Reel 4190 and Frame 0903 pursuant to that certain Collateral Assignment (Intellectual Property) dated as of April 22, 2010; and

WHEREAS, in consideration of the satisfaction of the obligations secured by the Security Interest, Administrative Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, Administrative Agent hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of Grantors' right, title and interest of every kind and nature as of the date hereof in the Trademarks (including, without limitation, those items listed on Schedule A hereto). All terms used but not otherwise defined herein shall have the meanings ascribed to those terms in the Security Agreement.

2. Release of Security Interest. In consideration of the satisfaction of the obligations secured thereby, Administrative Agent hereby terminates, releases, and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of Administrative Agent in such Trademark Collateral shall hereby cease and become void.


3. Recordation. Grantor, or its designee, may record this Release in the USPTO and in any other offices as may be necessary to carry out the intention of this Release and, to the extent applicable, Administrative Agent authorizes and requests that the USPTO record this release of Security Interest.

4. Further Assurances. Administrative Agent hereby agrees to timely execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby, in each case at Grantor's expense and in form and substance reasonably satisfactory to Administrative Agent.
