

Pursuant to Section 18-209 of the Delaware Limited Liability Company Act, the undersigned executed the following Certificate of Merger:

1. The name of the surviving limited liability company is Quadion LLC, a Delaware limited liability company (the "Surviving LLC"). The name of the corporation being merged with and into the Surviving LLC is Quadion Corporation, a Minnesota corporation (the "Merging Corporation").
