## ASSIGNMENT

**WHEREAS**, Continental Structural Plastics, a corporation organized under the laws of Delaware (“ASSIGNOR”), having its principal place of business at 755 West Big Beaver Road; Suite 700; Troy, Michigan 48084, has adopted and is using the Marks set forth in SCHEDULE A hereof which they have used in various countries throughout the world including the United States of America; and

**WHEREAS**, Continental Structural Plastics, Inc. (“ASSIGNEE”), a Delaware Corporation having its principal place of business at 755 West Big Beaver Road; Suite 700; Troy, Michigan 48084, desires to acquire the Mark and the goodwill of the business associated with the Mark.

**NOW, THEREFORE**, for good and valuable considerations, the receipt of which is hereby acknowledged, the ASSIGNOR does hereby assign and transfer to ASSIGNEE the entire right, title, and interest in and to the registrations for the Mark, and interest to the Mark not presently registered as set forth in SCHEDULE A hereof, together with the goodwill of the business symbolized by the Mark and the registrations thereof, and all other rights which Assignor has enjoyed thereunder both in the United States and throughout the world, including the right to recover based on past infringement of the Mark and/or registrations, the same to be held and enjoyed by the ASSIGNEE, its successors, and assigns forever and to the full end of the terms for which any of the aforesaid Mark are registered and any renewals of the terms thereof;

**AND FOR THE SAME CONSIDERATION**, the ASSIGNOR also hereby covenants and agrees that, at the time of execution and delivery of these presents, the ASSIGNOR is the sole and lawful owner of the entire right, title, and interest in and to the registrations and applications and believes it is sole and lawful owner of the entire right, title, and interest to the Mark and the goodwill associated therewith and that the same are unencumbered and that the ASSIGNOR has good and full right and lawful authority to sell and convey the same in the manner herein set forth;

**AND FOR THE SAME CONSIDERATION**, the ASSIGNOR hereby covenants and agrees that the ASSIGNOR will, whenever counsel of the ASSIGNEE or the counsel of its successors, legal representatives, and assigns shall advise that it is lawful and desirable, sign all papers and documents, delivers necessary documents including original registration certificates, if available, take all lawful oaths, execute separate confirmatory assignments, and do all acts reasonably necessary or desirable to be done for the procurement, maintenance, enforcement, and defense of the Mark and registrations thereof without charge to the ASSIGNEE, its successors, legal representatives, and assigns, other than reasonable costs and expenses incurred by the ASSIGNOR or any of its employees, agents, and representatives in connection with the foregoing actions.
