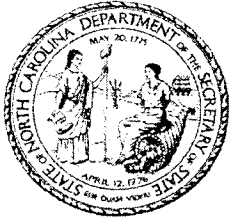

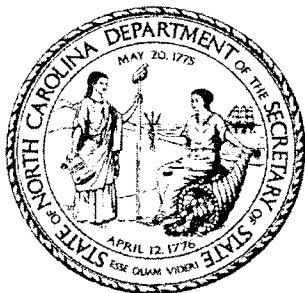


- 1. The name of the limited liability company is: Wicked Weed Artisan Ales LLC
